SAFE(R) Housing has been reassessed and strengthened to resolve rental housing discrimination and ensure access to housing for all. It encompasses stronger policies that reform tenant screening, support landlord-tenant communication, increase access to housing and protections for tenants facing displacement, in addition to easier access to landlord-tenant rights, responsibilities and resources. This ordinance also includes language around a pre-eviction notice so a landlord has to give a 30 day notice to a tenant before they officially give an eviction notice. This is a great start and we want more protections for renters in the years to come!
