Thank you for providing an opportunity to appeal the proposed exception allowing my landlord to exceed the 3% rent increase cap. Please accept the following as my written testimony.

One of the factors in my decision to move to Saint Paul in June of 2022 was the recent passage of the rent stabilization ordinance. I was encouraged by what seemed like a progressive effort to give renters a reprieve from out-of-control rent inflation. By allowing landlords to exceed the rent cap, I believe the city is circumventing the will of the majority of voters who approved the ordinance.

I also believe allowing an 8% rent increase would be unfair and excessive, especially considering my annual salary increases ( and average salary increases in general) are less than 8%.
