By no later than close of business December 10<sup>th</sup>, you must submit a nuisance abatement plan to our office. You can email that to me at <u>joanna.zimny@ci.stpaul.mn.us</u> or dropped off in person. This should include expanded use of cameras and lighting, a plan for routine exterior



maintenance. Per your discussion with Ms. Moermond it is advised you contact both Camphor United Methodist Church and the Frogtown Neighborhood Association about your plans.
