Native plantings in place



You may have seen signs like these around the campus off of Water Works Road or near the administration building. Late this summer, we planted native plant species around our water plant to enhance the environment and support local wildlife. Native plants are important because they provide essential food sources like nectar, pollen, and seeds for birds, butterflies, and insects. They require fewer pesticides and fertilizers, making them an eco-friendly alternative to lawns. Adapted to local conditions, native plants need less water, helping conserve this precious resource. Native plants help reduce noise pollution and carbon emissions from lawn equipment. Last fall, we also burned the rain gardens and channels in the parking lot to help dormant native plants re-establish themselves. And last fall, we also removed invasive plants and trees from the south end of the parking lot to help native plants thrive as well as provide space for better snow management in the winter months.
