- 7. All vehicles parked outdoors on the lot must appear to be completely assembled with no major body parts missing.
- 8. Vehicle salvage is not permitted.
- 9. There shall be no exterior storage of vehicle parts, tires, oil, or similar materials/items. Trash will be stored in the dumpster.
- 10. No auto repair of vehicles is permitted on the exterior of the lot or in the public right-of-way. All repair work must occur within an enclosed building.
- 11. No auto body repair or auto body spray painting is allowed.
- 12. Customer vehicles may not be parked longer than 10 days on the premises. It shall be the responsibility of the licensee to ensure that any vehicle not claimed by its owner is removed from the lot as permitted by law.
- 13. Provide maneuvering space on the property to allow vehicles entering and exiting the site to proceed forward as stipulated on the approved site plan.
