Think Before You Click: This email originated **outside** our organization.

Dear Legislative Hearing Officer and DSI Fire Inspection Division,

I am writing to formally appeal the findings of the recent fire inspection report issued for my property at 1090 Loeb St, Saint Paul, MN, 55117 and to file a complaint regarding the inspector's conduct during the inspection.

- Inspection date: 11/14/2025 and 12/15/2025
- Inspector name: Alex Dravis, CFI

My property currently holds a valid Fire Certificate of Occupancy, which confirms prior compliance with fire safety standards.

Grounds for Appeal and Complaint;

Improper Entry and Violation of Privacy:^[SEP] The inspector entered my fully enclosed front porch (a three-season enclosed porch with a storm door, multiple windows, and full walls) without my permission, prior notice, or consent. This enclosed porch is a private area directly attached to the interior of the home and protected under Minnesota Statute 504B.211 (right to privacy in rental/residential units) and general privacy protections for tenant and violates my Fourth Amendment rights, Minn. Stat. § 626.18, and Saint Paul Code § 34.24, Entry into such a private enclosed space for a routine fire inspection requires reasonable notice and consent, which were not provided. Furthermore, from inside the enclosed porch, the inspector looked into the interior of my home specifically through the interior door window without permission.

The Violations Cited Appear Minor or Unjustified:^[SEP] The violations listed (and which have been taken care of) in the report seem minor and not critical to fire safety. I believe the inspection was conducted in an overly strict or selective manner, leading me to feel unfairly targeted.

Potential Discriminatory Treatment:^[SEP] I felt the inspector's actions and tone may have been influenced by bias related to my national origin/race. This has caused me significant distress.

I request the following;

- Immediate stay of enforcement of any correction orders or re-inspection fees until this appeal/complaint is resolved.
- Full dismissal or modification of the violations cited in the report.
- Investigation into the inspector's conduct during this inspection.
- Schedule a legislative hearing if necessary to present my case.
