As has been discussed before, we were awarded funds from Minnesota Housing Finance Agency to perform the rehab. Here is our current projected timeline:

5/10/24: Building Only Inspection Requested and Fee Paid
6/7/24: Scope of Work completed for bidding
6/21/24: Bidding closed; contractor selected
6/24-7/12/24: Construction loan underwriting, title work, acquisition closing scheduled
7/19/24: Acquisition closing; rehab work begins
2/1/25: Rehab Complete
4/15/25: Resale to owner-occupant
