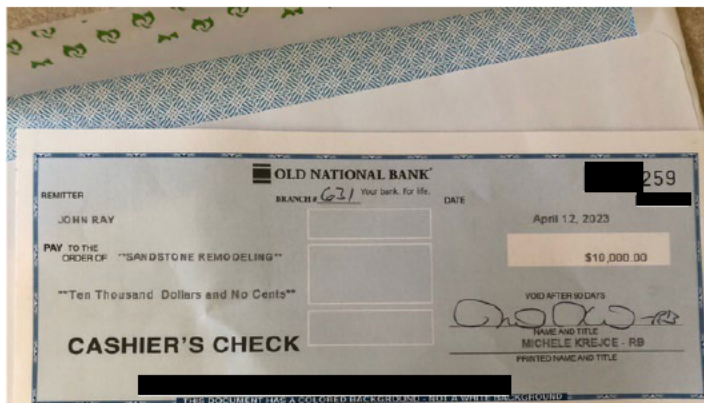
Can we ask "why" that's necessary when
