PRIOR TO THE CREATION OF NFSU (1/2024), NON-FATAL GUN SHOT WOUND (GSW) ASSAULT CASES WERE INVESTIGATED BY THE **HOMICIDE/ROBBERY UNIT**



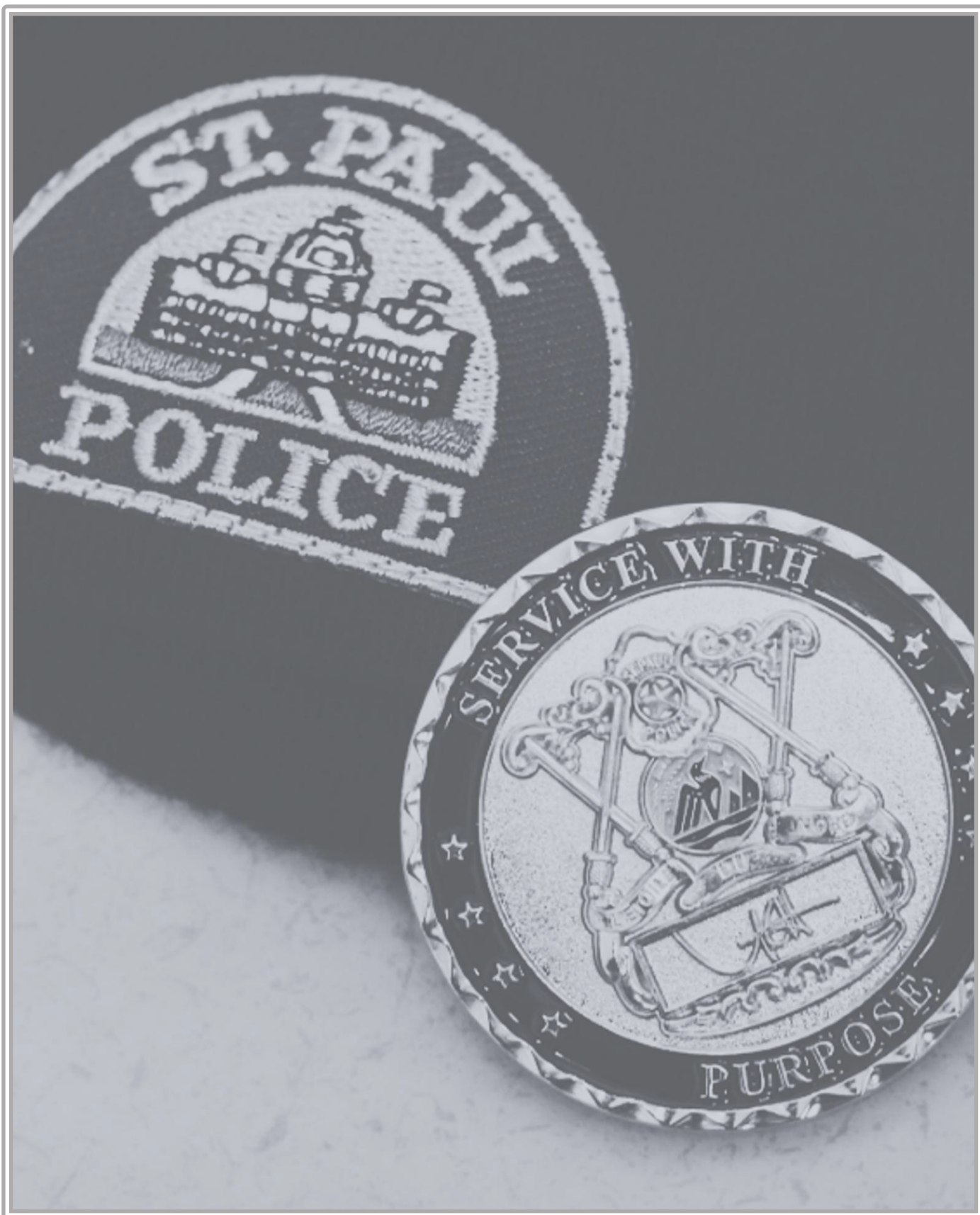
- TASKED WITH SEVERAL TYPES OF HIGH PRIORITY CASES
- BEGAN NON-FATAL AGGRAVATED ASSAULT INVESTIGATIONS THE FOLLOWING DAY/MONDAY
- HEAVY WORKLOAD

WHY WAS NFSU CREATED?

- INCREASE PUBLIC SAFETY
- REDUCE GUN CRIMES
- INCREASE COMMUNITY TRUST BY HOLDING SHOOTERS ACCOUNTABLE
- IMPROVE CLEARANCE RATES OF NON-FATAL SHOOTING CASES
- PARTNERSHIP WITH RAMSEY COUNTY ATTORNEY'S OFFICE
- RECEIVED STATE PUBLIC SAFETY MONEY TO INVESTIGATE GUN RELATED CRIMES
 - \$2,999,999 OVER THREE YEARS (2024-2026)

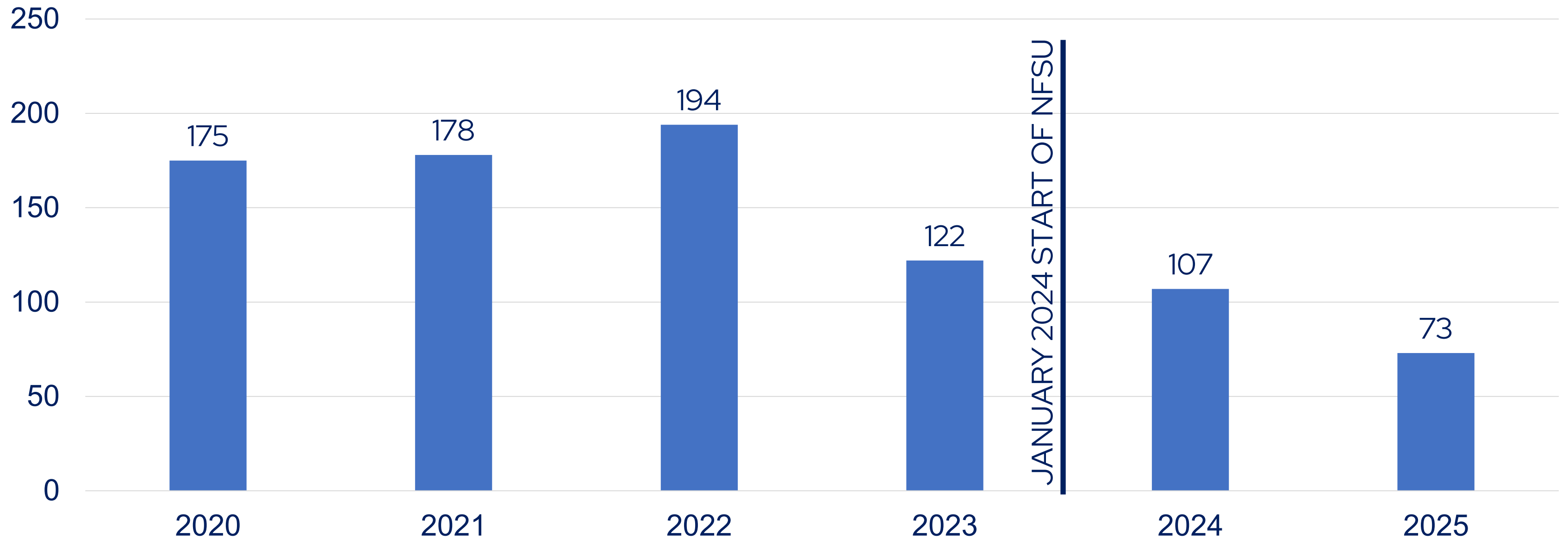


- **INVESTIGATIVE SCOPE**
 - ALL ASSAULT CASES WITH A GSW VICTIM
- **A TEAM OF 6 SERGEANTS, 2 OFFICERS, 1 COMMANDER, 1 ADMINISTRATIVE ASSISTANT**
- **INVESTIGATORS WERE PULLED FROM OTHER UNITS WITHIN THE DEPARTMENT**



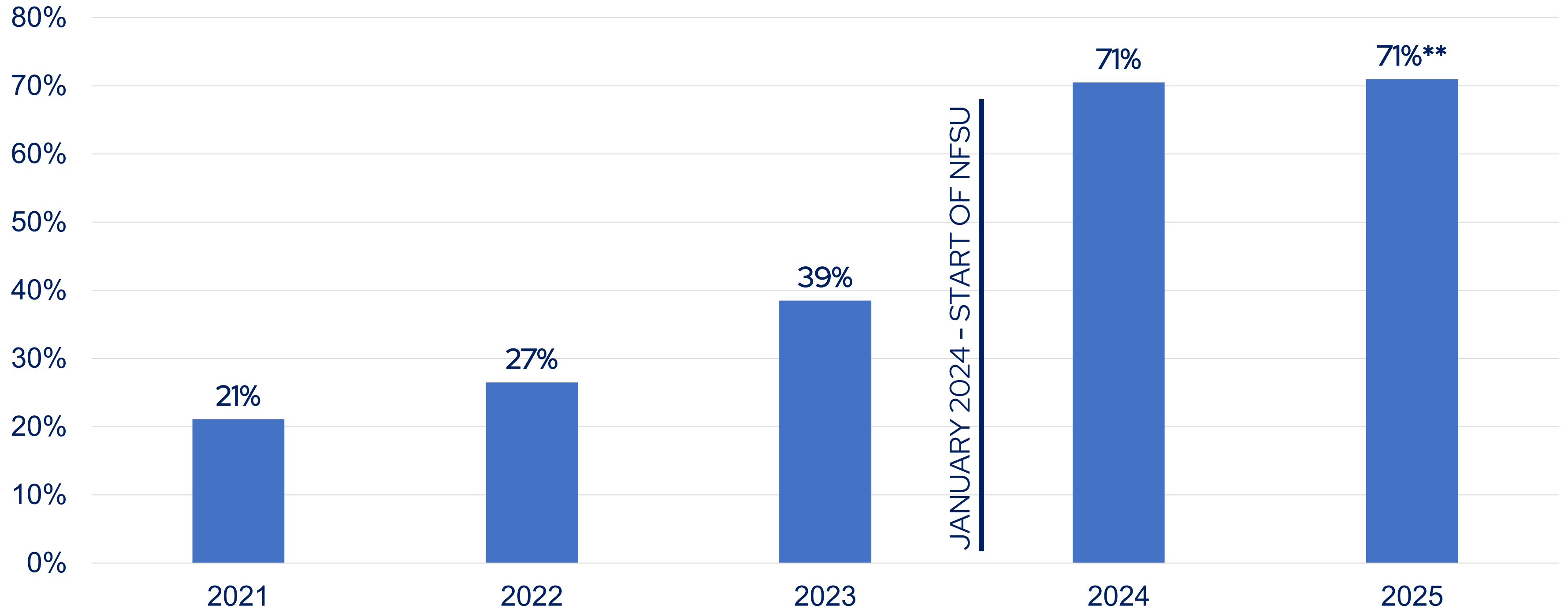
- TEAMS OF 2 RESPOND WITHIN ONE HOUR OF THE INCIDENT
- INVESTIGATE EACH CASE AS IF IT IS A HOMICIDE

NON-FATAL GUNSHOT WOUND VICTIMS IN SAINT PAUL



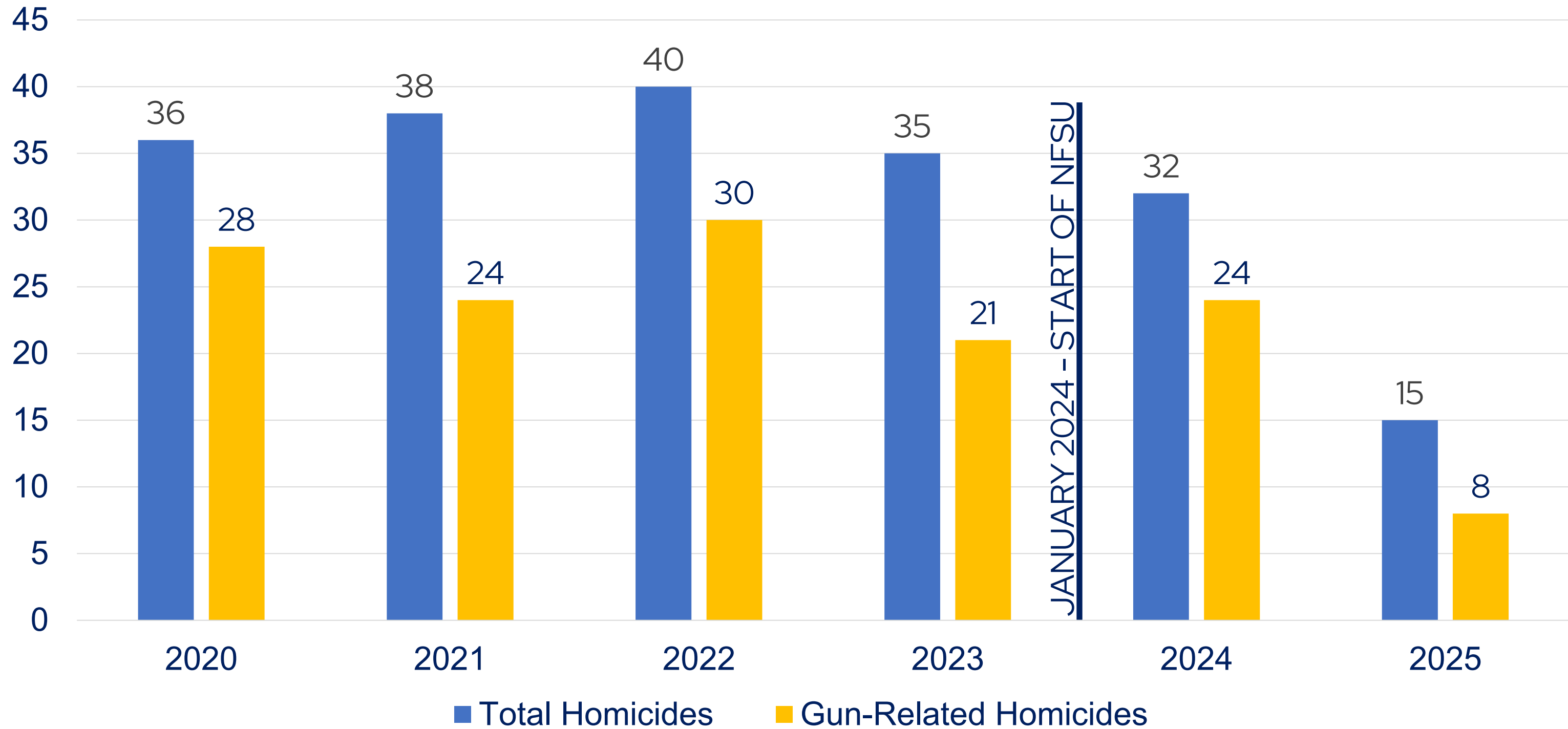
SINCE THE INCEPTION OF NFSU, AGGRAVATED ASSAULT VICTIMS WITH GUNSHOT WOUNDS HAVE DECREASED 40%.

PERCENTAGE OF AGGRAVATED ASSAULT WITH GSW CASES THAT HAVE BEEN CLEARED BY ARREST



**THERE ARE 7 CASES FROM 2025 THAT ARE STILL BEING INVESTIGATED

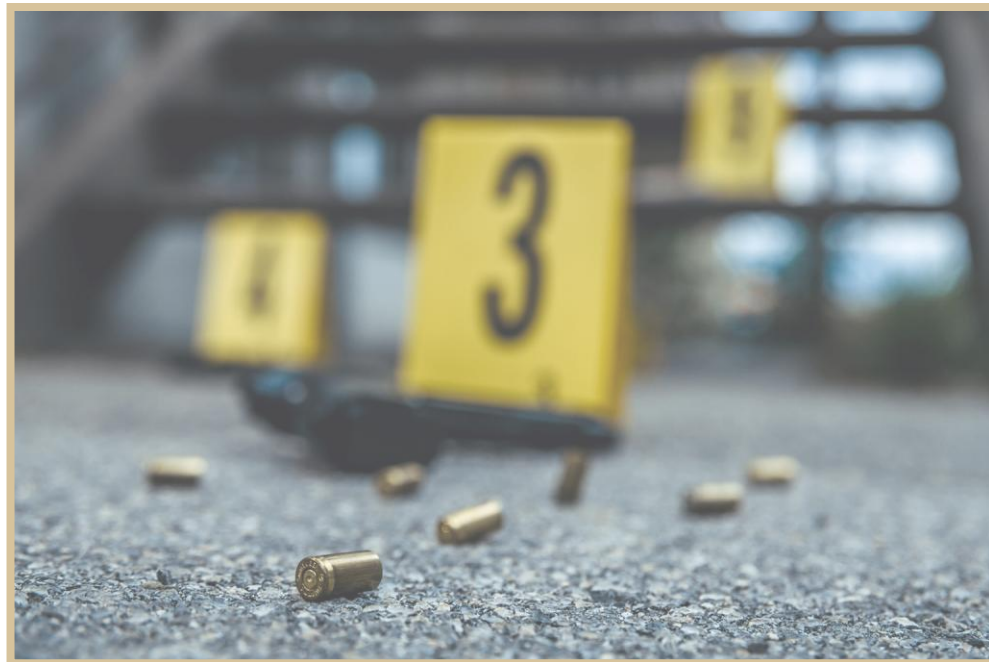
HOMICIDE VICTIMS IN SAINT PAUL



SINCE THE INCEPTION OF NFSU, GUN-RELATED HOMICIDES HAVE DECREASED 62%.
