Please take notice that this matter has been set on the Council Hearing Agenda for a City Council meeting on **Wednesday, July 19, 2023 at 3:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed is a copy of the email we received from you on June 20, 2023 requesting that we cancel the administrative hearing that was scheduled for June 26th and June 27, 2023. Your email indicated that your client was not contesting the facts related to the incident but was instead requesting the opportunity to address the Council regarding the penalty, the resolution, and any supporting documents. Based on your request, we drafted the attached resolution. This information, along with the Notice of Violation and supporting exhibits, will be presented to City Council for their consideration.

As you are aware, this matter is related to a complaint-based inspection conducted by inspectors from the Department of Safety and Inspections on January 9, 2023. During that inspection a large volume of prohibited flavored products and unstamped cigarettes were discovered hidden in boxes and tubs, behind a drawer and under a foot board at the base of the sales counter in violation of Saint Paul Legislative Code §324.07 (j).


