## UDF and LVEX: What do They Stand for and Why do I Care?

As a utility, we perform preventative maintenance on all sorts of systems, from pumps to hydrants to our tunnel system. The UDF, Uni-Directional Flushing, and LVEX, Large Valve Exercise, programs are the two preventative maintenance programs specifically targeting watermains and valves.

Uni-Directional Flushing is a 5-year cycle program where we operate valves and flush small diameter (8" and smaller), watermains.
Routes are determined for all of the small mains, then valves are strategically closed to force the water within the system to flow in one direction discharging from a hydrant with the routes working over from the plant to the outer edges of the system. The primary purpose is to remove any excess treatment sediment from the water mains to improve water

quality. Water samples checking chlorine and turbidity are taken and tracked to monitor the water quality. The huge side effect of this process is the valve operation. To achieve the needed isolation, a large

percentage of our system valves need to be operated. To operate the valves, each valve needs to be located, the valve box cleaned out,

and then verified that the valve works properly. Thus, even though UDF is about water quality in the main, the system valves which control the flow are the major benefactor of the process.

The Large Valve Exercise program, LVEX for short, picks up where UDF leaves off. Because UDF is limited to 8" and smaller mains, larger valves sized 12" and greater are missed as a result. The remaining mains that not a part of UDF are also grouped into routes for ease of coordination. Within these routes, any valves that are connected to the large mains are located, valve boxes cleaned out, and either fully operated or verified that they operate. These larger valves tend to be critical valves, ranging is size up to 42" within the distribution system.

There is additionally a separate special route that includes all the finished water valves within the campus.

Due to the nature of these activities, specifically flushing involved with UDF, this preventative maintenance work is done late March through November and put on hold during the freezing temperatures of the winter. From spring to fall, there is generally a 5-person crew dedicated to UDF routes and they focus on UDF for most of the construction season. For LVEX, two smaller crews of 2-3 people work on those routes generally in the mid-summer through late fall as crew availability allows with construction. Unfortunately, the demands of a construction season can adversely affect how well these routes can be done.

Some years, such as this year, preventative maintenance has to take a back seat to construction. This year's planned UDF crew had to pivot to a new role setting up, maintaining, and taking down the extensive temp water system that was in place in downtown Saint Paul. Because of that need, we will be entering the winter at a disadvantage as valves have not been checked or operated within their 5-year cycle as they should have been. This also creates a trickle-down effect of placing the program a year behind. So even this seeming easier work will affect the crews this winter season, thus highlighting again why preventative maintenance is so critical and needed to keep our system running.

### Strengthening Our Partnerships: Using CERT to Source Local, Diverse Vendors

At Saint Paul Regional Water Services (SPRWS), our mission is to provide high-quality water and exceptional service to the people and communities we support. The CERT Program is a collaborative initiative between the City of Saint Paul, City of Minneapolis, Hennepin County, and Ramsey County. It was created to make it easier for public agencies like SPRWS to connect with small, minority-owned, and woman-owned businesses across the region. Once a business completes the CERT application process



and meets program criteria, it's added to a shared vendor directory used by all four participating jurisdictions.

Through this directory, staff can quickly access a robust database of certified businesses offering a wide range of goods and services — including construction, engineering, IT support and more.

Using the CERT directory is an excellent way to strengthen our procurement process and broaden our pool of qualified vendors. It enables project managers, buyers, and contract leads to identify businesses that help us meet our diversity, equity, and inclusion goals while also promoting competition and improving value. The directory can be searched by company name, service type, certification type, and other criteria, allowing staff to efficiently find vendors who meet project needs and send solicitations directly.

Incorporating CERT vendors into our sourcing efforts also reflects SPRWS's broader commitment to supporting the local economy and representing the diversity of the communities we serve. By intentionally engaging certified businesses, we not only increase opportunities for small and underrepresented companies but also foster innovation and strengthen relationships with local partners. Many CERT-certified businesses bring unique expertise, creative solutions, and specialized skills that



enhance the quality and effectiveness of our projects.

Accessing the CERT directory is simple. Once staff members have access through the program's website, they can immediately begin exploring potential vendors.
