Good afternoon Ms. Tvedten,

I'm reaching out on behalf of Marcia Moermond, Legislative Hearing Officer for the St. Paul City Council. We got your information from Shari Moore in our office, if there's a better person to reach out to please let me know.

We have an appeal by Ron Staeheli, 358 Arbor in St. Paul tomorrow. There was an investigation in 2018 in which it was found they were registered to vote. Staff notes from that are below:

- **Voting** – Per Ramsey County investigation, Diane Staeheli has been registered to vote in Eagan since 2002. In 2014 she attempted to change her voting address to 358 Arbor, but this was declined, as US Mail to confirm her residence was returned to the Election Office. She re-registered to vote in Eagan in 2018 and voted most recently there 11/6/18. (This is inconsistent with Ron Staeheli's testimony in a September 2018 Legislative Hearing that she lived at 358 Arbor Street.)

The Eagan address is 4300 Blackhawk Rd, Dakota County

We were wondering a couple of things, 1) are either Diane or Ron registered to vote at 358 Arbor now, and is it possible to tell if they voted in this past election?

Second, Shari had indicated she thought if someone changed their voting location of record, that the previous County gets notified of that change? Can you confirm if that's true?

I hope this makes sense. Please let me know if you have questions/need clarification.
