Good morning,

Cindy Westphall called Ward 5 for assistance regarding their property at 362 Westphall. She's lived in Ward 1 for 42 years and 1 year ago had a house fire. They wish to rebuild. She is reporting that they're having issues with DSI including:

- A sewer requirement
- When sewer issue was addressed then DSI required property be surveyed before they could pull their building permits;
Unfortunately the surveyor cancelled last week due to weather;
- Now they are coming up on their 1 year anniversary of the fire without any permits being pulled and she believes there has been extenuating circumstances why they have not yet pulled the permits; wants to avoid any more costs incurred from DSI

I asked if she has appealed orders and had a hearing with Marcia Moermond? Cindy said that there had been some discussion by the City of her not responding to a postcard sent and that she was having issues with the Post Office and did not receive any notice, which was a bit contentious with the City.

I did tell Cindy that I would take this information, but would forward it to YingYa Vang for her to work with her council representative's office.
