Many folks in the greater Twin Cities metro have been disappointed with police accountability during Operation Metro Surge. I personally have witnessed police officers turning a blind eye to illegal actions of ICE and CBP officers. The police will happily pull over residents on patrol who are following ICE vehicles in order to legally and constitutionally observe their actions, yet they will completely ignore vehicles with one or both license plates removed. ICE will dangerously weave through traffic at high speeds, and will be ignored by police, yet residents tailing them will be pulled over and receive a citation.

This change in administrative code might not stop officers from aiding or being complicit, but it will reduce the risk through training and hopefully provide a sanction for those who ignore the separation ordinance or are sympathetic towards ICE actions in MN.

Dear Mayor Her and St. Paul City Council Members,

I have been a resident of Ward 6 for the last 11 years, and I can honestly say I had never spoken face to face with a St. Paul officer in that time until the day the ICE came to the block of 600 Rose Avenue last November.

I had seen ICE agents hanging around the Auto store in the days before then, looking for random black or brown auto workers most likely, who they could ask for citizenship "papers" and possibly pick up. So it wasn't a surprise to hear that they were fixated on a house on Rose Avenue, and that they were not giving any reason or showing any warrants that justified their presence there.

I was surprised that St. Paul police officers were there in such huge numbers, and it was impossible to tell them from ICE agents in many cases. When I talked to them, they didn't want to answer questions that I had about who they were protecting from whom. When the incident was over, St. Paul officers (acting on behalf of ICE?) threw gas bombs and sprayed rubber bullets at dozens of people.

I hope that St. Paul police officers understand the damage that they did that day, acting on behalf of the masked intruders to our area, and then gassing us on the way out, as if they didn't work in this community, and as if we were the enemy.

I hope that this ordinance can keep that from ever happening again. I fear it might not go far enough. Before this day, I thought there was a vast difference between how an ICE agent might act versus how a trained police officer might act.

We have learned to expect ICE agents to act lawlessly and with disrespect. I had no idea that it could come from the St. Paul police.

Please pass this ordinance and give your constituents some hope that there is accountability in law enforcement, and that police will work with residents and not against them.

I'm writing in support of ORD 26-19, Chapter 44A. At this time, it's so important that we are building trust and clarity with our communities. The language within this ordinance is a strong step toward transparency, building trust, accountability, and reporting. The impacts of "Operation Metro Surge" are still being felt, and the chaos and harm it has brought upon our friends, families, and neighbors is manifold.

I'm encouraged to see language that helps affirm what our local services should serve and what they should not. We all need to be able to clearly see that our local LE is in adherence to our city ordinances and practices as it promotes safety and security, but also because this ordinance will create a bridge where one is so needed.

The actions that took place at Rose Avenue were deeply harmful. The use of non-lethal munitions, the violent levels of crowd control, the real physical and emotional harm done to residents, workers, and even students in the areas, was palpable. We don't want to see incidents like these, and we certainly don't want to see incidents where SPPD is operating in a way that helps operationalize federal immigration actions nor instances where law enforcement also does harm to public trust.

I hope this council will work together to advance ORD 26-19 to full passage. The community is looking for accountability and transparency. Much thanks to y'all for the continued efforts to push forward needed and strong legislative actions that are about all of us as St Paul community members.
