Toxicity Council:

\with all respect to the work done so far, we urge you not to have a final vote on this legislation. While all the legal requirements for public comments have been filled, it's undeniable that a huge proportion of city residents still do not know about this. There will be years of recriminations if this legislation passes with so many questions not dealt with.

For instance:

--There is no protection against private equity continuing to buy residential property, taking it forever out of the hands of local individuals. Faraway holders of private equity, whose view of our city's housing is as only another random investment vehicle, are not one bit concerned with the well being of our city or its residents.

--Far too much of the potential housing can be short-term rentals. While this may be a good investment (especially for those private equity folks, who are not local) it completely fails to serve the needs of our actual residents. Seriously---especially since every new development proposed contains a hotel or two, where are all these visitors to St Paul going to come from? Our actual residents will be damaged by this.

--Not enough genuinely affordable housing is likely to result from the legislation. Too little is asked for, and what is asked for is for people above the 60% level, which leaves a lot of residents still unhoused.

St Paul, and you City Council members, can do better.

Attached is an excerpt from a collection of studies that conclude that Short-term rentals exacerbate shortages of long-term housing availability. It also seems to be associated with rent increases.

Why would the City of Saint Paul encourage short-term rentals within zoning amendments that have the stated purpose of increasing housing availability?

If this type of inconsistency exists within a single portion of the proposed zoning amendments – it is difficult to image that there are not similar negative impacts hidden within other changes to these far-reaching zoning code amendments.

Please take more time to evaluate all aspects of the changes and to reconsider approval of the 1-4 Unit Housing Study – Phase 2 Zoning Amendments in its current form.
