Amending the 2025 Saint Paul Regional Water Services spending budget to record the cost-neutral change in spending for the cost of issuance, principal and interest due on PFA note DW10.

2025 STRATEGIC PLAN GOALS: Financial Stability

The Board's 2025 adopted budged included \$3,798,286 for principal, interest and cost of debt issuance for the McCarron's Treatment Plant project. PFA note DW10 for \$28,000,000 is scheduled to be signed and closed by December 2025. A new accounting unit was created for the debt service on the note. This order will authorize the Office of Financial Services to assign the debt service to the appropriate accounting unit.

This administrative order will result in no increase or decrease in spending. The 2025 Budget accounting codes to be revised are included in the attachment and summarized below.
