Thank you for sharing that a "solid selection process" has been "vetted and approved" and now is in place. Given the significant role and influence of the Commission—and the responsibility it carries on behalf of the community—I want to respectfully highlight the importance of approaching this process with care, discernment, and integrity.

The community has placed its trust in this body to uphold the highest standards of accountability and public stewardship. The decisions made here have the potential to set a powerful tone and inspire confidence, while advancing the spirit of equity, restoration, and renewal that this work represents.

It's also important that both the City Council and the broader community are fully informed, and that the process presented is clear, transparent, and aligned with the Commission's commitment to legacy-led leadership and meaningful community voice. A process that reflects thoughtful engagement and due diligence will help ensure that both the Commission and Council are well-positioned to move forward together in shared purpose.

In that spirit, I would be grateful for any information available regarding:

- The composition of the selection committee (including names, if appropriate)
- The expertise represented on the committee
- The extent of community representation—excluding staff and Commission members

In reviewing the process, it appears that a staff committee will be reviewing proposals against the RFP criteria and scoring them accordingly. Following that, a selection committee may conduct interviews. If accurate, I want to gently raise that this structure and process may not currently include legacy community members—whose lived experience and historical connection are central to the Commission's purpose. Including those voices meaningfully in the process could further strengthen community trust and alignment with the Commission's values.

In my humble opinion the community would be best served by a selection committee that is robust in its inclusion of community voice, technical expertise, and scholarly understanding of the subject matter. Such a composition would reflect the depth and complexity of the work ahead and ensure that the process is both credible and responsive to the community's aspirations.

Lastly, if there is any uncertainty among Commission members or the public regarding the purpose, process, responsibilities, or expected deliverables, I believe it's always worthwhile to pause and seek clarity together. Taking the time to build shared understanding and confidence will only enhance the integrity and impact of this important work.

Thank you again for your leadership and dedication to this transformative effort. I look forward to continued collaboration in service of our shared vision.


