2. Licensee shall maintain an approved barrier that physically separates and defines the licensed service area to ensure the sale, display and/or consumption of alcohol remains within the approved area.
3. Per City of Saint Paul Legislative Code 4 Sec. 409.08.(21), no sales, display and/or consumption of alcohol under this license may take place within the gaming areas designated on the approved floorplan whenever persons under 21 years of age are present in that space.
4. No liquor sales and/or service is allowed outdoors without prior written approval and additional licensing from DSI.
