MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF SAINT PAUL AND AFSCME CLERICAL LOCAL 2508

This Memorandum of Agreement (hereinafter "MOA") is entered into by the City of Saint Paul (City), AFSCME Clerical Local 2508 (Union) for the purpose of establishing tuition assistance, a uniform allowance, and eligibility for consideration for scholarship grants provided grants are funded for Saint Paul Police Department Community Engagement Cadets.

- 1. This agreement shall only apply to Community Engagement Cadets employed with the Saint Paul Police Department.
- 2. The City and the Union desire to provide all Community Engagement Cadets tuition assistance towards the completion of the Peace Officer Standards and Training (POST) certification requirements and an annual uniform allowance as specified in this MOA.
- 3. The provisions of this MOA shall be effective upon signature of all parties.
- 4. Each Community Engagement Cadet shall receive an annual Uniform allowance in the amount of seven hundred eight dollars and forty-eight cents (\$708.48) towards purchase of required Uniform items as set forth in Appendix A, attached hereto.
- 5. The City shall provide tuition assistance to Community Engagement Cadets to cover the full cost of tuition for enrollment of up to nine (9) educational credits at Century College or the equivalent at another accredited educational institution.
- 6. Community Engagement Cadets who successfully complete POST education and skills program requirements and successfully obtain POST certification may also be eligible for consideration to receive a third-party grant funded educational scholarship award provided the funding is available to establish the scholarship grant. This MOA does not guarantee funding will be available to establish the scholarship contemplated herein or that other scholarship funding will be available.
- 7. In the event the scholarship grant is funded, a Community Engagement Cadet must meet the following criteria in order to be eligible as a candidate for consideration of a scholarship award if available:
 - Proof of completion as a student in a Professional Peace Officer Education Program (PPOE) Skills program recognized by the Minnesota Board of Peace Officer Standards (POST).
 - Have completed all Career and Occupation Requirements and all General Education and Elective Requirements to acquire an associate degree in law enforcement through an accredited institution that meets POST academic standards.
 - Currently in the title of Community Engagement Cadet.
- 8. Application of the terms of this MOA shall not be grievable.
- 9. This MOA shall be effective upon signing by both parties and renew annually unless one party provides notice of a desire to end.

10. This MOA sets no precedent.
