Hi Joanna,

Please forward this to whoever it concerns.

I'm going to need another extension for the stage we're at in the process because I'm still waiting on the rest of the estimates for the HVAC and plumbing. Every business I contacted is very booked up and there was no way for me to get the estimates done before today.

I finally have a plumber coming to do an estimate today at 1 PM by Kelly Plumbing. Here's a copy of the email:

"We can have an estimator arrive at 887 Charles Ave on Monday, September 9, between 1 – 1:30pm *pending prompt response.

And I have Boehm Heating coming for an estimate, but that's on the evening of Sept 18. unless someone cancels and they can get there sooner.

Here's the confirmation email by Boehm:

"Our estimate calendar is booking out a couple weeks; we have an opening the evening of Wed 9/18. Jeff would arrive between 5-6pm. We can certainly try to move this up sooner if we have any cancellations in the meantime."

I'm still trying to get additional estimates.

I had another electrical estimate done last Friday by Elofson Electric, but he hasn't sent me that estimate yet.

Sorry for the added delay, but I'm on their schedules and I should have all the estimates within a couple weeks.

In the meantime, I would ask that the \$75000 old estimate, (which I have not been given a copy of the details that came up with that number) be reduced by at least half, given the currently listed scope of work to get the house up to code.

I would also ask that the property be considered to be placed back to category 1 or 2 vacant property because a couple of the inspectors mentioned that the house is in much better

condition than the average category 3 property. So it doesn't seem right for it to remain as a category 3.

Again thank you for your patience, I'm on the schedules for all the estimates but I can't make them come over any sooner than what they have available.
