I was charged for nine additional garbage bags. Three bags were charged on 11/25/2025 and six bags on 12/2/2025. I requested photos from those dates, which public works provided. The photos show one additional bag on 11/25/2025. On 12/2/2025 the bin tipped over the in the snow. There were no additional bags. I requested my bill be amended to reflect what was shown in the photos: one additional bag on 11/25/2025. The hauler only agreed to remove charges for four bags. I have attached the photos and screenshots of the email conversation. I have not received a response to my last email from March 13.
