This is to confirm that at the Legislative Hearing on October 8, 2024, Legislative Hearing Officer Marcia Moermond will recommend that the City Council refer the matter back to Legislative Hearing November 12, 2024 for further discussion on condition that by no later than November 4, 2024:

- 1. A \$5,000 Performance Deposit is posted with the Department of Safety & Inspections; and
- **2.** a **Code Compliance inspection** with the Department of Safety & Inspections has been applied for

- 1. appear in person (please arrive before 3:30 p.m. and check in with staff outside Council chambers); or
