Ordinance establishing OFS Grants division

- Provide support and technical assistance to departments in:
 - Prospecting and grant writing
 - Grant management and compliance
 - Grant strategy and planning
- Implement grants manual that sets citywide policy and procedures
- Facilitate training for departments to build knowledge and confidence
- Report on citywide grant activities



Why is this ordinance necessary?

- Codifies the Grant division similar as the rest of the OFS divisions
- Gives the Grant division authority to set citywide grant policies, including approving applications before being submitted
- No budget implications from this ordinance

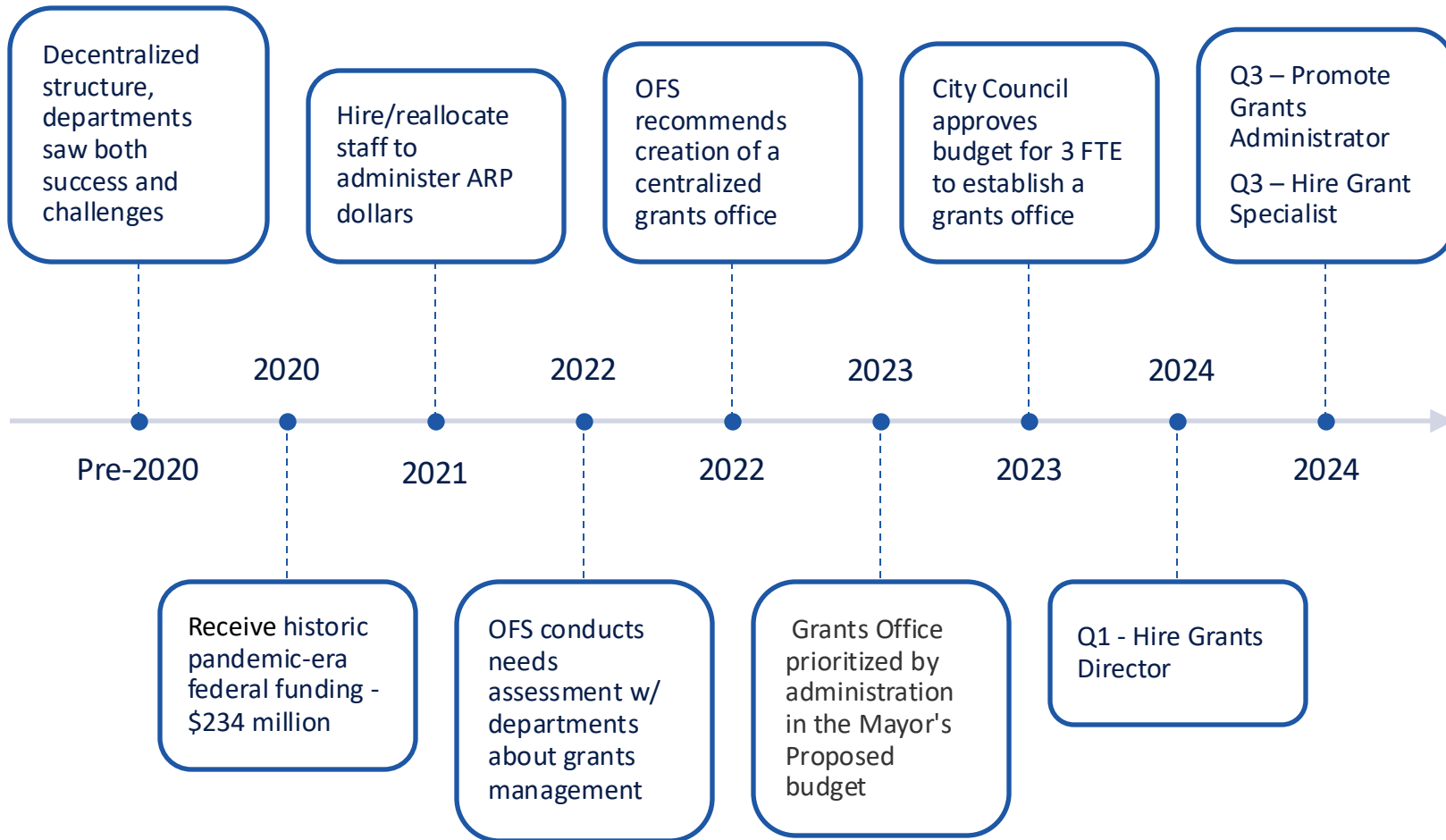

2022 Needs Assessment findings

- Strengths:
 - The City has collaborative models for grant development that work well and create staff pride
- Challenges:
 - The City lacks centralized policies and processes for grants, resulting in audit findings
 - The City lacks a centralized file management system for grant contractual documents
 - The City does not have grant data in an easily accessible format or system
- All departments supported and recognized the need for a centralized grants office
- Participants' most frequently requested resources:
 - City-wide policies and tools for grants management
 - Trainings around Federal CFR regulations and other compliance requirements
 - Grant prospecting and application coordination
 - Grant writing

Examples of work to-date

- Citywide policies and procedures
 - Developed Grants Manual to support departments with established policies
 - Implementing the Intent to Apply process to review grants being submitted
- Grant prospecting
 - Identifying priorities with departments and creating prospect lists to review and plan for upcoming proposals – Public Works, Immigrant and Refugee Services, Resilience team
- Grant writing
 - Assisting Library with Digital Equity proposal (\$6.8M), Fire and Fleet with MPCA Heavy Duty On-Road proposal (\$1.4M),
 - Analyzing merit criteria score and making improvements to score highly for Bridge Investment Program proposal (\$43.7M)



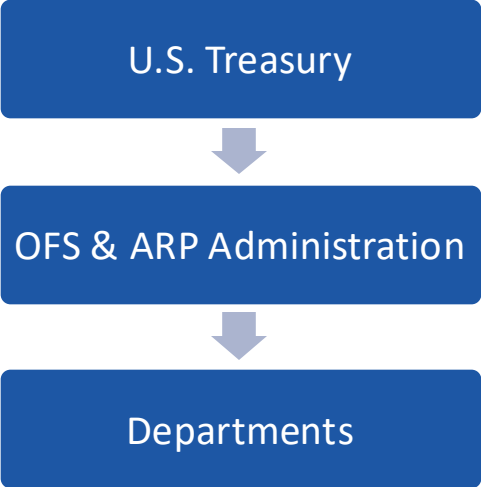
Examples of work to-date

- Grants management
 - Technical assistance on new cross-department grants, including subrecipient management and documentation
- Training and skill building
 - Conducted training on 2024 updates to the federal 2 CFR 200 regulations and preparing grants for the new federal administration
- Strategy and planning
 - Identifying and tracking match sources for grants
 - Contingency planning around federal grant uncertainty/freeze

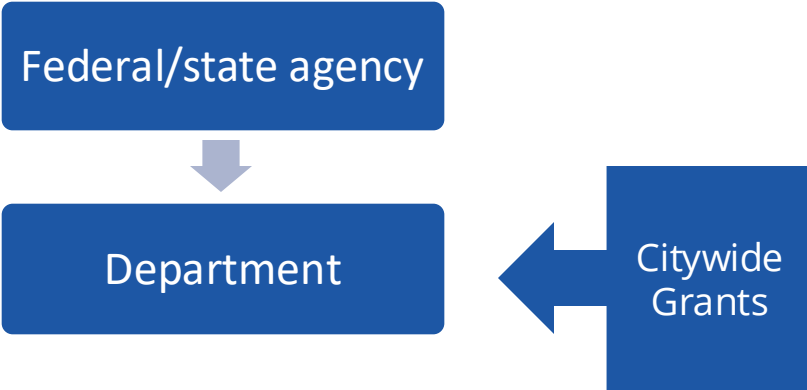


Citywide grants compared to ARP

What's next for the Grants team?

- Codifying the grants ordinance
- Continue financial analysis of the City's federal portfolio and planning with departments for potential changes to federal landscape
- Fully launching the Intent to Apply process – will provide better data on grant applications across departments
 - No change to Council approval of grant applications
- Finish strategic planning in early 2025
- Identifying a grants management software for the City to manage grant applications, funder relationships, and active grants, will provide better access to data on grants at the City-level
 - Preparing to make a budget request in 2026 budget process
