## Staff Comments

Highland Sanitation is billing PO for two non-sufficient fund checks written in Q3 and Q4 of 2023. These checks posted to PO's garbage account on September 18 and November 14 2023, but Highland Sanitation did not know they were non-sufficient fund checks until February 22 2024. PO should be the charged regular service fee of \$112.57, plus late fees, totaling \$129.46 for Q1. Staff recommends reducing Q1 2024 from \$293.27 to \$129.46

Hello Lucy,

Lydia forwarded your case to me and asked me to reach out. I am a Management Assistant and primarily work with garbage tax assessments.

The picture of the bill you sent over to Lydia (dated: May 1, 2024) is actually for your current Quarter 2 (April - June) 2024 bill. The payment was due April 25, 2024. It is an overdue bill that will not be sent for tax assessment until end of June. You can still pay this Quarter 2 (April - July) 2024 bill directly to Highland Sanitation without a legislative hearing. Please submit payment to Highland Sanitation by calling them or sending payment to the address on the letter you received. If you wait to pay this, there will be another late fee added to the bill on May 25th, and another similar overdue letter will be sent out from Highland Sanitation.

Your Quarter 1 (January - March) 2024 bill has been sent for tax assessment. The balance is \$293.27 and payments will need to be made to the City of Saint Paul Assessments Office. Because the Assessments Office holds this bill, there are no additional late fees or interest added to this balance until November. You can also make partial payments to the Assessment Office on this bill, up until November. If you do not agree with the amount that has been assessed to the city, you can request a Legislative Hearing to state your case in person or over the phone. If you request a Hearing for this bill, your Hearing date will either be the morning of July 11 or July 25. I will know the exact date in a few weeks.

We also reached out to Highland Sanitation to try and find out what was going on with your bills and why they are higher than a typical bills. They responded, stating you sent a few checks from two different bank accounts that were returned Non-Sufficient Funds or Account Not Found. There is always an additional fee added when that happens. Highland Sanitation says they emailed you a few times to let you know about your payments failing with no response. They also say you were planning on talking with your bank to straighten everything out, but never reached back out to Highland Sanitation with an update.

If you paid Highland Sanitation within the service period of Quarter 1 (January - March) 2024 and believe the assessment was applied in error, please provide verification of payment and we can investigate the matter further. If you would like to contest the Quarter 1 (January - March) 2024 assessment for any reason and request a legislative hearing, please reply to this email stating you'd like to appeal.

Spoke to PO directly. Notes from conversation:

- Payments made in 2024:
  - 1/17 for \$95 (record of this shared by Lucy and confirmed by Highland)
  - 1/31 for \$35 (record of this shared by Highland, but no record shared by Lucy yet)
    - PO does not think she has made any payments since this.
- Regarding the high bill-- PO states that she thinks she has a medium cart, she does not have YW service, and she did not set out extra bags or bulkies in 2023.
- PO was not assessed at all in 2023 for garbage.
- In 2023, she contacted Highland regarding an issue where the driver was leaving the lid of her cart open.

Lucy,

Again, I am so sorry for the issues you're having with your garbage payments. Below are the details from our phone conversation.

- **Can you please share a copy of any payments you've made to Highland since mid-January 2024?**
  - I already have an image of the 1/17/2024 payment that you made.
  - If you had sufficient funds when the checks were cashed, please share any proof that you have, such as emails with the staff at your bank.
- If you are unable to send via email, you can share details in-person and we can make copies here:

- 8AM - 5PM
- 25 W 4th St, Floor 8, St Paul, MN
  - If you call in advance, someone can meet you outside if you're worried about parking. Call 651-266-6101
- The hearing to contest this isn't until July 11 (and there is a backup date of July 25), so there is no rush.

I am waiting to hear back from Highland with responses to some of our questions. Specifically, why your bill is so high. The only additional charges I can think of that would be added are: late fees and/or fee for check bouncing.

Hi Lucy,

I apologize for the delayed response. I heard back from Highland Sanitation about your Quarter 1 (January - March) 2024 assessment, and why \$293.27 is owed. Highland is applying returned checks from previous quarters to your Quarter 1 (January - March) bill.

- The Quarter 3 (July - September) 2023 returned check for \$61.61 (sent September 18, 2023) was added to your Quarter 1 (January - March) 2024 bill
- The Quarter 4 (October - December) 2023 returned check for \$120.20 (sent November 14, 2023) was added to your Quarter 1 (January - March) 2024 bill

Highland Sanitation should have sent the City of Saint Paul a pending assessment for Quarter 3 and Quarter 4 each separately instead of adding the returned check fees to the new Quarter 1 (January - March) 2024 bill. I will be recommending a reduction in your assessment at the Legislative Hearing on July 11th. Your attendance is optional.

I will recommend the Quarter 1 (January - March) 2024 assessment of \$293.27 is reduced to \$129.46 for Quarter 1 (January - March) 2024. Here's the breakdown:

- Quarterly rate is \$112.57 for a medium sized 64-gallon cart
- Late fees are \$5.63 each (there are 3 in each quarter)
- $\$112.57 + 5.63(3x) = \$129.46$

I am recommending the regular quarterly charge for Quarter 1 (January - March) 2024, plus the late fees to remain because that bill was paid with returned checks and was sent to us for assessment in the correct timeframe, which is the proper procedure.

A few questions:

- Have you made a payment to Highland Sanitation for Quarter 2 (April - June) 2024 yet?
- If your bill for Quarter 2 (April - June) 2024 has been paid, what payment method did you use?
- Did you figure out the billing mistakes that were causing the checks to be returned NSF?
