The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **October 10, 2024** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

1. SPLC 34.08. - **PARKING**: Parked or stored vehicles. Before any existing parking spaces or driveways may be expanded upon, site plan approval must be obtained as specified in the Saint Paul Zoning Code and the lot must be developed in conformance with such approval.

IMMEDIATELY DISCONTINUE THE ADDITION OF THE GRAVEL PARKING AREA ON THE NORTH SIDE OF THE GARAGE. A SITE PLAN MUST BE APPROVED BY THE CITY FOR ANY PARKING AREA ADDITION OR MODIFICATION. ANY NEW PARKING AREA APPROVED BY THE CITY WOULD BE REQUIRED TO BE ASPHALT, CONCRETE OR PAVERS. THANK YOU.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on or after **October 17, 2024**, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in an abatement and/or additional fees for re-inspection.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)
