address, 1125 Hague Ave. PO did not realize the error because they had autopay set up. Error came to light when PO called to report a missed collection and WM stated they had no account on file for the address. PO states that they paid WM \$500 in Sep 2023 and now received an assessment for \$208.52.

It was not permissible for PO to have charged for services dating back more than one quarter.
