**Voicemail from Sharon Anderson to Marcia Moermond left Monday, September 30, 2024 12:58 PM from 651-241-8211:**

Marcia Moermond this is Sharon Scarrella Anderson, owner in fee title 697 Surrey and also a republican nominee in 67B. Right now, finally, I'm getting served with something. The gal from Ramsey County, I don't [mumbled] jurisdiction. My house is occupied! With all my personal possession. We're going to have to have an itemization of each piece of paper. Don't you know what, Marcia? We're going to reopen *Magner vs. Gallagher*, United States Supreme Court Case. On one hand I'm happy we're going to get this open. A tiny little 30 oz bottle is about 60 bucks with OcuVite, and I had a huge bottle. I'm not finding it right now. I'm telling you, the warrant is relevant. The hospital never should have admitted me. The paramedics, they said, "We'll take her back home" before anything was boarded up or anything. The work does not have a file number or case number. You guys are ass backward. I'm going to make a lot of money off of this. You are criminally trespassing on private property without due process of law. If there was a condemnation, it was August 8th, by a social worker that didn't have, she's not a process server until I get served by the Sheriff Fletcher. It's a condemnation notice that I have a right to object, have a right to get a lawyer, blah blah blah. You're, I'm going to say Bishop, of a vacant building. You better guide yourself accordingly, because now with an appeal to the City Council. Who represents the City Council? It's not later until the Mayor and Therese Skarda to sign off on it. I'm going to nail Therese Skarda. For five years I've been trying to tell an opinion on a Lakes & Land survey. Now we're gonna go through the whole process and we will end up before the Ramsey district judge. You can't issue a warrant without a file number, but she did, and the hospital accepted it. And Nikki said that right now today, and she's kind of laughing. But, I found my MAGA hat. I want my vitamins. I want this stuff straight. Note the action and cross complaint by the reckless disregard of human suffering, pain and suffering. Then go and take bobcats 6 inches from the gas line on your [unintelligible]. You're gonna blow up the whole damn neighborhood.! Guide yourself accordingly. Get that appeal as fast as possible.

Then the City Council is tied in. Give it a timing, the tight end, and if the Mayor and Skarda sign off on it, they are tied in, we will go to court before the Ramsey district judge as soon as possible because she is in a warrant with no file number. That's digital malpractice. Goodbye.

Marcia Moermond, this is Sharon Skarella Anderson, still at the hospital. You better have a foundation of any of these condemnations, uh blah, blah, blah. Who's making the complaints? You better take pay attention. That warrant. Who made a complaint? And the paramedics at the hospital should...there's nothing wrong with me. They should have put me right back in my home. In a way, it's the hospital's fault. It's the Police, the paramedics, and I'm going to get to the bottom of this. I'll stay alive just to fight you people. You've been around a long time, too long. You've been readily notified. The amount in controversy with the abstract, which you're not qualified to try Title 2. There were 40 lots. 697 Surrey was the main one. You better pay attention to the legalese. No way is my house vacant. It's going to end up in court by a crooked Chief Judge, Sarah Grueing that issues warrants that don't have a file number, a case number. And who made the complaint to the chief judge to issue the warrant? That's where it starts. September 9th. Goodbye, girl. No matter what you do, I'll appeal anything all the way to the US Supreme Court. Like I did in <http://sharon4anderson.blogspot.com> when the city arbitrarily shut my water off. Bill and I went to federal court. Goodbye.

Marcia Moermond, this is Sharon Skarella Anderson, owner in fee simple of 697 Surrey. Now, I pay the electric bill every month. It's occupied. I pay the water bill every three months. It's occupied. The phone bill, my ISP provider. That's \$105.00 every month. I pay AOL every month. UCare. It's occupied because I'm paying the bill. If you are conducting under the Racketeering Act, thanks, Steinhauer, with the United States Supreme Court case 10-1032. My property taxes are paid in full on a homestead basis. You can't have a vacant building within one month. The whole issue is the warrant. You can't have a warrant without dissenting the particulars, without a case file number. You can't do it. I called the police chief. He's a rotten police chief. I believe that he has acted outside of his authority and jurisdiction to file a complaint to the judge. There's no case file where the subject matter starts and begins and ends. This whole crap starts--who is making complaints? You better get your ducks in a row, girl. No matter how you roll. I own that property. You understand? I own all 40 lots from 1888. The amount in controversy is over millions of dollars. I'm not going to be threatened any longer by Ted Cobin. Who is making these complaints? Lisa Martin? She can't. She has never been in the building. And then on August 28th, that's when this shit started. And the cop, Matthew, threatened me that he's going to call the paramedics and put my dog in a shelter. Why is a cop threatening me, he's going to call the paramedics? The 30th of August, they're pounding on the door. Why are they pounding on the door? And I think that's when they put a placard, Order to Vacate, which I didn't know until a couple of days later. That gets us into

September. Now, who is filing these complaints? You do not have subject matter jurisdiction over a vacant building because it's not vacant when I pay the bill. Then let's get 701 Surrey. Vacant over 25 years. Give me a break. I'm in the hospital as a ward. As a technically, I'm a ward of the State. The amount of controversy, what's it costing? Every day, every day, every day? This is an election case. Better get your ducks in a row. Goodbye.

**Thursday, October 10, 2024 12:50 AM**

Marcia Moermond, I'm not dead yet. Now, did you expedite your hearing on the vacant building? It should have been heard Wednesday. I need the document. We don't have cable television in the hospital. I'm still here, and I'm getting very upset. My health has been impaired big time. Now, did you expedite the hearing before the Council yesterday? If not, why not? We're going to get this into court. I demand to be back in my home. If in fact there was a condemnation before Lisa Martin, where is it? Who heard it? Technically, I've never been served with it. You better expedite that hearing and get it before the Council so the Mayor Carter can sign off on it and then go to District Court. And the warrant has no file number. So, am I civilly committed? I need my home, my inventory, and I need an answer and cross complaint against your... you are purposely delaying a crisis matter. I'm still in the hospital. This is costing Ramsey County. Eventually I will win this. I will get back in my little 100-year-old house, and the case law is "Kaido vs. Newfoundland". The other case was United States 10-1032 Magner vs. Gallagher, and you know it. Lisa Martin is a defendant in that case. So is Steve Magner. I want my home. And if you do not expedite it, why not? Why not? Let's get it in the court. Let the world know what's going on. And I'm not dead yet, but I'm getting close to it. Goodbye, Marcia.

**Thursday, October 10, 2024 5:49 AM**

Marcia Moermond, this is Sharon Skarella Anderson. Your total disregard for my rights. You have never called me back after I've made about 15 calls. You have failed to have an advocate for me at this hearing. Your reckless indifference to have a fair, impartial, hearing, and you're going to argue with me when I have a right to a defense. You cut me off. I know how corrupt you are. Your job should be eliminated. A house that is exempt. You did not conduct a fair hearing. My list of witnesses are: Bill Dahn. He knows that the water is turned on in the basement. Handyman, 285-7657. My second list of witnesses is Arturo Lee, my handyman, 432-7000. The third list of witnesses is the United States Senator Gwen Wright, Wright, pardon me, bright white. I want him notified. And the list of witnesses the United States Senator must have included in your documents the affidavit. Do you understand? Second list of witnesses is Tom Emmer, who's the...for Donald Trump. With the affidavit, all documents of condemnation of... And the third list is the Ramsey District Judge. List her warrant. September 9th. That must be in your file. Because you cannot proceed with bogus work that is null and void, and on and on and on. The third list of witnesses would be: Probably the sheriff. I want the sheriff in attendance of anything that you think you're doing. This whole thing, more like. You don't have the jurisdiction. Whenever subject matter in authority are challenged, you cannot proceed any further, but you're doing it. You're going further. This is an election case. What in the hell?
