This is to confirm that at the Legislative Hearing on Tuesday, January 7, 2025 Legislative Hearing officer Marcia Moermond will recommend that the City Council:

1. Grant to January 27, 2025 for compliance with the Summary Abatement Order; and
2. Grant to February 3, 2025 for compliance with the Vehicle Abatement Order

This matter will go before the City Council at Public Hearing on **Wednesday, January 22, 2025 at 3:30 pm. in room 300 City Hall**. If you are contesting Ms. Moermond's recommendation you may:

If you don't wish to contest then **no further action is needed** and the Council will proceed with Ms. Moermond's recommendation above without discussion.

The City Council Public Hearing for the January 28 hearing will be scheduled for Wednesday, February 5, 2025 at 3:30 pm. in room 300 City Hall. The City Council Public Hearing for the February 5 hearing will be scheduled for Wednesday, February 12, 2025 at 3:30 pm. in room 300 City Hall. You are welcome to attend any of these hearings. If you are contesting Ms. Moermond's recommendation from those hearings, you may appear in person or, **should you wish to address testify by phone you must**
