Marcia Moermond, Legislative Hearing Officer: I am asking Council to amend the resolution to forfeit \$2,500 from the performance deposit if the Certificate of Code Compliance is not issued by the January 10, 2024 City Council meeting. I am not asking for adoption today. I met with the owner in the hallway earlier and we discussed this thoroughly. The performance deposit right now is at \$10,000.

Marcia Moermond, Legislative Hearing Officer: This is the fourth resolution on the item. In January 2023 you had an appeal on a Fire Certificate of Occupancy (FCO) inspection that related to an electrical socket and a baseboard radiator that was installed vertically and uncovered. Council granted an extension for compliance on the heater to March 1. Then on March 27 you granted another extension to September 1. Noncompliance on that day caused its FCO to be revoked just for this unit in the building. The radiator has been covered, but not with a traditional baseboard cover. The question is whether the installation here is code-compliant. The finding on that requires referral to the building code's mechanical code chapters. That isn't something that Council has the ability to decide. That would go to the building official for appeal, and subsequently to the state for an appeal of that decision. A building code appeal form was sent to the appellant, and I recommended to Council to grant until December 1 to file that appeal. That resolution was referred to Council for public hearing on November 15. Our team accidentally placed it on the

agenda for November 8, where it was considered and voted on. The letter we sent to the appellant said November 15. We rescheduled the public hearing to today. You may wish to grant an extension beyond the December 1 date embedded in the resolution, but I think the issue is still the same. They still need to file that building code appeal in order for this to be considered code-compliant. The Department of Safety and Inspections (DSI) issued a follow-up order on December 15 to reiterate where things were at.

Council President Brendmoen: Could you clarify your recommendation?

Moermond: I am recommending that an extension be granted to December 1 (though I invite Council to grant a further extension) to apply to the building code official for an exception or accommodation that would determine if this is a code-compliant installation. Any extension given by the building official to do additional work would be on its own track. Because it had its FCO revoked, it was referred to the Vacant Building Program. Therefore, I am also recommending that the Vacant Building Fee be waived for 4 months, which takes the waiver to mid-January. If it goes unpaid, it would be considered for assessment by the Council also.

Councilmember Prince: Are you recommending an extension to mid-January?

Moermond: I recommended that the Vacant Building Fee be waived until then, since it can be an impediment to getting work done to bring things into code compliance. My recommendation on the extension to apply for a building code appeal was to grant until December 1, though again I invite Council to extend it further.

Prince: What would you recommend as a further extension?

Moermond: Originally, the December 1 deadline was a two-week extension from the November 15 Council public hearing. Given the holidays, I think January 11 is as far as I would push this out to be consistent with what was before you on November 15.

Brendmoen: So, Mr. Lehman, you heard Moermond's comments.

Greg Lehman: I didn't understand what she meant at all.

Brendmoen: It sounds like we are going to look at a mid-January extension on an opportunity to make things right. We don't need to relitigate this. Part of this needs to go to the building inspector, which we are not.

Lehman: The fire inspector approved it all. I've got a letter here from Fire Inspector Ryan Tessman saying it was all approved on December 11, 2023. Then on December 13, right before the City Council meeting that day, I got an email from Adrian Neis, saying that my FCO was revoked because I needed a permit. I don't know what I need a permit for.

Moermond: I have pictures up now of the installation. That's what I wanted him to be able to speak to. The permit process would be the mechanism by which that installation's code compliance would be determined. I wanted him to be able to see that.

Lehman: But that isn't a finished product. I have the finished photo here. The right one is before, and the left one is after. It's all enclosed now. No one can get burned. There are no sharp edges. It looks like it's part of the building. I never touched the pipe. I just built around it. I asked DSI staff if I needed a permit to put a cover over a baseboard heater, and they said no. Information I have on paper here also says I

don't need that. It's not structural and cost under \$500.

Prince: We've talked, and I appreciate the confusion here.

Lehman: I'm going 10 months without a rental. No one is telling me what kind of permit I need to get. I'll do it if someone can tell me.

Prince moved to close the public hearing. Approved 7-0.

Prince: We appear to have continually approving, and now we aren't. Could you address this confusion.

Moermond: The confusion has been spoke to on many occasions. The building code appeal form has been provided to the owner. It has been explicitly stated that the building code appeal form is the mechanism by which this could become an approved installation. I understand the frustration, since there have been multiple FCO inspections where this has not been called out. The fact is that if it hasn't been called out in the past, but is being called out in the present, it doesn't mean that it was okay in the past. It means it was missed. We have sent letters on multiple occasions to chart a path for the owner. I know that when you call around and talk to different people, you get different answers. The \$500 threshold for building permits is not what we are talking about today.

Brendmoen: We could extend the waiver on the vacant building fee and building code appeal to February 21, 2024. That would give time for the new councilmembers to get brought up to speed on this and give more time to get that building code appeal in.

Prince: To clarify, if we grant an extension to then, it's so that Lehman can meet with a building official to determine what was required for the installation? You also mentioned an appeal to the state building code, but that's outside of anything we are doing here, correct?

Moermond: Yes. The resolution says right now that the vacant building fee will be waived until January 15, 2024 (though it sounds like you want to change that to February 21, 2024) or the deadline established by the building code appeal determination. It grants until December 1 file that appeal (though it sounds like you also want that deadline extended to February 21, 2024). This is the only item left to come into code compliance.

Prince: I don't know how long the building code appeal process takes.

Moermond: Once the appeal is accepted, the building code official could chart that path. I don't know how long it will take either. I have seen them processed relatively quickly.

Prince: So, we will grant until February 21 for the determination?

Moermond: I was hearing from you that it was to make an application for an appeal, not for having a determination made by the building official. I heard that he would need to have all of his paperwork in for that by February 21. The building code official would take it from there.

Lehman's partner (no name given): Where is this application?

Moermond: You have the form attached to several messages. We can send it to you again.

Brendmoen: There's a motion from Prince to grant until February 21, 2024 to apply for the building code appeal and waive the vacant building fee until then as well.
