I am so sorry for the delay in my response. The hauler did not reply to us until October 5 and then it fell off my radar due to other duties. Based off the information that you shared showing that you did not have any missed payments, I plan to recommend that the assessment for April-June 2023 be removed. That said, I am new to my position, so I need to check before confirming that I can do this for you. I will also check on my ability to remove the two assessments prior: October-December 2022 & April-June 2023. I am also waiting on Waste Management to reply to my latest inquiry asking if they have anything to add or dispute.

If you disagree with the recommendation that I end up making, you are welcome to contest it at a legislative hearing. Please let me know if you would like the details of how to do so.

I wanted to give you an update about the assessments on your account for delinquent garbage bills.
