Hi, this is Sharon Gorilla Anderson with a public comment that the mayor's 8% property tax increase, I'm objecting to that. The City Council 5% increase, I'm objecting to that. Let's go with I've been victimized by the city in their Ponzi taxing scheme, particularly with my homestead address at 697 Surrey Ave., which has been arbitrarily vacated and condemned without a public hearing. Now you must include the hearing on April October 23rd that included my answer and cross complaint and the as far as the vacant building is concerned. But it had a copy of the warrant which must be included in this thing. And then Fred Milos notes letter and arbitrarily cut off the answer and cross complaint for compensatory \$1,000,000 punitive \$1,000,000 in tort that you have victimized 697 Surrey with an illegal condemnation in September 17th. A worthless warrant done by the police chief that forced medical care on Sharon Anderson without this is Medicare fraud. You are double taxing. I paid the property taxes in full for 6973 at a full homestead. I've been there 35 years and then you arbitrarily Jahala dismissed my answer across complaint and the fact that the social worker Lauren who's trying to get my home back restored social worker Loren 2661285 and she said remove it to fed remove it to Ramsey County District Court. The warrant that is illegally used that you are arbitrarily denying, stated the Chief Judge of Ramsey County District Court. Sarah Grilling stated there's probable cause to believe a crime has been committed without the 609 statute or without a Ramsey District Court hearing. This involves taxation without representation, forced medical care without a medical issue. I'm not sick, therefore my Medicare benefits. The city is involved in Medicare fraud I'm objecting to any type of property tax increase based upon Magna versus Gallagher 10-1032 United States Supreme Court and then the quid pro quo in 2017 when Carter sat on the City Council. And the quid pro quo, the bribe was Lily Hogg, who's dying of Parkinson's right now. But at that time he was a city attorney and the good, the bribe, what he was made a Supreme Court Justice and he ruled that right of way attacks and not a fee.
