Hi Tom,

We would just deal with the obstruction. Since they do not have furniture on the sidewalk and are not obstructing the ROW we would not have to issue them a permit. As far as carrying alcohol across the sidewalk, I think that would be regulated by DSI. Worst-case scenario is that they aren't allowed to have "open" vessels of alcohol in the street. In that case, it would seem that they could carry closed bottles and open them at their table on private property. I think that after we figure out exactly what the rules are, this would really be an enforcement issue. Meaning that we would turn a blind eye until the city receives complaints about drunken and wanton behavior in the ROW.
