Please Note the Following:

Tree Cutting

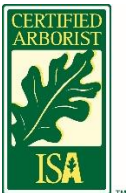
- Unless specifically stated, all debris will be removed from the tree removal or trimming.
- Tree trimming of deadwood is down to 1-2" in diameter. We are not able to chase after smaller deadwood.
- Please clear your yard of dog debris before we arrive. We may add a fee if we have to add a clean-up.
- Please move your decorative items out from under the trees we will be working in. If you need help with heavier objects let us know – we can do that.
- Please stay clear of our work/drop zone.
- Most of our crews have communication in their hardhats, talk to the guys on the ground when it is safe.
- *Tree work is scheduled by the day, not time. Each day is arranged that morning. We cannot predict with any accuracy what time we will arrive.*
- If you decide to add-on work, please arrange for that before we schedule your work. Add-ons will change your estimate. Most likely your job is not the only job for the crew that day.
- Please read your estimate carefully – work to be completed is on the estimate. If you are unclear about some aspect of the estimate, contact us!

Stump Grinding

- Stump grinding is separate from the tree cutting. It will be priced out separately.
- Unless it has been stated otherwise stump cleanup is not included in stump grinding (nor is new soil).
- We need to know where your underground hazards are – sprinklers, dog fencing, lighting etc. We do not look for these unless we are aware of them.
- If your stump is surrounded by rock, please be aware that you will want to rake away that rock. The stump grinder will fling rocks.
- Not all stumps are doable. We will do our best to accommodate your situation.

Payment

- Acceptance of this estimate is binding, until it's not. Things change but please notify us ASAP to cancel or postpone. (Please note: if we mobilize a crew to your address and for some reason you did not cancel with us ahead of time, we will charge a \$250 mobilization fee.)
- We will invoice once the job is complete. Online invoicing gives the option of paying online.
- We can work out payment plans and do take all major credit cards.
