Mr. Elzamel,

This will not be dismissed without a Legislative Hearing. If you choose to *not* participate Tuesday your next step will be to testify to the City Council directly (of which the date and time of you will receive at a later date). The layover is standard procedure when we don't reach someone on our first attempt. You are not penalized in any way for missing a Legislative Hearing.

We dialed the number on the appeal form. You also could have called the contact number on the appeal form (of which you received a copy of when you filed your appeal) when you believed you didn't receive a call as noticed. You did not do that. You also never contacted our office after believing you didn't receive a call on Tuesday, until receiving today's letter, all of which are typically done by appellants if they believe their case was missed in error.

We will again be calling you next week, at the number provided. If you wish to provide an alternate phone number to attempt to reach you in case we find ourselves in a similar situation, you are welcome to do so. As always, you are also welcome to appear in person if you prefer, and as you have done in the past.

While I appreciate the offer to reschedule for January 13, I must respectfully request that the matter be dismissed instead, due to the city's failure to uphold its procedural responsibility to contact me for the scheduled hearing.

I was available from 2:00 PM to 4:00 PM as instructed, yet I never received a call. The department has stated that my voicemail was full, but my phone carrier's official call log shows that no call was received from any city number during that timeframe.

Because I complied with the instructions and the city did not successfully complete the call, I was denied a fair and timely opportunity to be heard. Under administrative and due process principles, the burden to execute the scheduled hearing properly rests with the city.

For these reasons, I request that my appeal be dismissed in my favor rather than rescheduled. Please confirm receipt of this request and let me know if you would like me to forward the call log as documentation.
