Therefore staff recommends reducing the assessment to \$320.43, which is the base service level cost for two 64-gal carts and one 96-gal cart.

Hi Team,

Hope your March is starting off well (and spring comes quick!). I am the owner of a 3 unit owner-occupied multi-family in St Paul. I recently discovered that since starting with Highland Sanitation a few years ago, I've been charged for four canisters instead of three. When I raised this with my provider, Highland Sanitation, I was offered

a credit only for the current invoice, not for the past several years. When following up, I did not receive a response. I've attached the email here.

I'd appreciate any help here. I have paid hundreds of dollars over what should've been billed to me and would like a credit issued to cover. I understand clerical errors happen, I'd just like a speedy resolution. Thank you!

Hello John,

I got more information regarding your account from Highland Sanitation. They confirmed that you have only had three carts at your property since the beginning of the program (2 x 64-gal carts & 1 x 96-gal cart). Unfortunately, we are unable to request that they credit you back for any previous billing periods since they were not notified of this issue earlier. Since there are two pending assessments for unpaid garbage bills from July - Sept and Oct - Dec 2022, we can reduce both these to \$320.43, which would be the base service level cost for the carts that are currently on your property. Since they both will have to be reduced via a legislative hearing assessments, this will not be done until the end of May 2023. I will send you a notice once both assessment amounts have been reduced.
