Staff has analyzed the property's potential eligibility for NRHP eligibility, based on significance and Current integrity. NRHP evaluation criteria assisted in the assessment of eligibility:

Criterion A ("Event" the property contributes to the major pattern of history.)

Criterion B ("Person" the property is associated with a person significant to the past.)

Criterion C ("Design/Construction" the property has distinctive characteristics of architecture, engineering, or construction, including having great artistic value or being the work of a master).

Criterion D ("Archeology") the site may have yielded or may be likely to yield, information important in history or prehistory."

This structure is less than 50 years old and as such is ineligible for the NRHP.

Also, as part of the analysis, staff evaluated the integrity of this structure to convey any potential significance as defined by the National Park including location, design, setting, materials, workmanship, feeling, and association, and if the property retains the identity for which it is potentially significant.

This review was accomplished with sufficient documentation to enable any reviewing parties to understand its basis.
