If objections to issuance of the license(s) are received, a hearing will be scheduled before a Legislative Hearing Officer. Anyone submitting comments will receive notice of the time, place and date of the scheduled hearing. At that hearing, the Legislative Hearing Officer will take testimony from all interested persons. At the end of this hearing, the Legislative Hearing Officer will make a recommendation to the City Council as to whether the license request should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to grant or deny the license.

Recommended License Conditions:

1. Per City of Saint Paul Legislative Code 409.15(a)(2), On-sale wine license shall mean a license authorizing the sale of wine not exceeding fourteen (14) percent alcohol by volume, for consumption on the licensed premises only in conjunction with the sale and service of food (menu item only). The sale of Malt (Strong) will also take place only in conjunction with the sale and service of food.
2. Per City of Saint Paul Legislative Code 409.15(e), licensee must be able to show that gross receipts are at least sixty (60) percent attributable to the sale of food.
3. Licensee will submit to the Department of Safety and Inspections (DSI) annual gross receipts for food and liquor for each year the license is renewed.
4. Licensee agrees to take appropriate action(s) to ensure that the sale, display, and/or consumption of alcoholic beverages is contained within the defined alcohol service area as per the approved plan on file with the Department of Safety and Inspections (DSI).

Dear Applicant:

Our review of your application for a license is in process. Notification has been sent to owners and occupants of nearby properties, community organizations and other interested parties giving them until **Tuesday, December 26, 2023** to submit comment on your application. If no objections are received, and you have returned a signed condition affidavit if applicable, a recommendation for approval of your license(s) will be placed on the City Council consent agenda.

If objections are received a legislative hearing will be scheduled. You will receive notice of the time, place and date of the scheduled hearing from the Legislative Hearing Officer. At that hearing, the hearing officer will take testimony from all interested persons and will make a recommendation to the City Council as to whether the license(s) should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to approve or deny your license application.

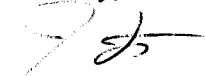
Requirements including the following must be met prior to license issuance:

- Sign and return one copy of the enclosed license condition affidavit acknowledging the conditions that will be placed on your license(s). A return envelope has been included for your convenience.
- Submit a signed letter from the property owners specifically stating the sale of 3.2 Malt On Sale (i.e., beer) is permitted for consumption on the premises. This was not specifically stated in the lease.
- Contact DSI License Inspector Ross Haddow at 651-266-9143 to schedule the required on-site review of DSI's Liquor License Manual.
- Provide a Certificate of Insurance showing you have secured liquor liability insurance coverage. It's recommended you wait until a determination is made on when a license could be issued to secure this insurance coverage since your license must run concurrent with the insurance expiration date.

Finally, Once City Council has approved your license and you have met all applicable requirements, *the approved paperwork and City license will be forwarded to the State of Minnesota Alcohol and Gambling Enforcement Division (AGED). You would then need to contact AGED to obtain your Buyer's Card (NOTE: AGED conducts an on-site inspection for a location that has not previously been licensed to sell Wine On Sale before they'll approve a Buyer's Card. AGED has stated they do not schedule an inspection until the City has completed its review of your application and sent them the approved paperwork). AGED will send you your City license once they have finished their review.*
