### Safety Challenges

- Violence and threats of violence
- Racist comments
- Sexual harassment
- Medical incidents
- Substance use, untreated or under-treated mental health issues, support for people who are unsheltered or experiencing crisis.
- These are challenges for all public spaces, not just libraries



# Funding for Library Safety and Security in general fund has been flat since at least 2014.

- \$135,000 annual General Fund support for systemwide safety and security.
- Current spending focused at George Latimer Central, Rondo, and Rice Street.
- Allocation has shifted over time.
  - Pre-2019: contract security and off-duty uniformed police officer.
  - Since 2019: contract security and Library Community Ambassadors.
- 2022 and 2023 budget savings being used to support additional contract security roles



### **Additional Safety Investments**

- Substitute staffing pool General Fund
- 1.0 Library Social Worker contracted service General Fund
- Trauma-sensitive and de-escalation training for all staff Special Funds
- Partnerships with community agencies (e.g. Community Resource Outreach Project, Radias Health, People Incorporated, Womens Advocates) in-kind
- Library Staff Safety Committee General Fund (staff time)
- Partnerships with city and county partners (Office of Neighborhood Safety, St Paul Fire Department, St Paul Police Department, City Attorney's Office, Emergency Management, Parks and Recreation, Saint Paul – Ramsey County Public Health – General Fund (staff time) and in-kind
- Building upgrades and renovations to enhance safety through design CIB, General Fund (library maintenance funds)



### Alignment with City's Community First Public Safety

- Library Director and Deputy Director on bi-weekly meetings
- COAST and CARES resources in libraries working with community members on a regular basis – via CROP (drop-in resources), calls to 911 and calls to CARES directly for support.
- Offices of Neighborhood Safety and Emergency Management on project leadership team, Neighborhood Safety Community Council as advisory
- Regular collaboration between libraries and parks and Office of Neighborhood Safety on service and safety issues



### **\$1.5M ARPA: Library Optimal Response: underway**

- Acknowledges the important role libraries play in community, the complexity of libraries as deeply accessible public spaces, and the commitment of SPPL to helping create proactive, comprehensive, community-centered approaches to public safety in Saint Paul.
- Will support:
  - External review and assessment of existing library public services safety resources;
  - Creation of a comprehensive public services safety plan
  - Creation and pilot implementation of a new staff role of safety specialists.
- Cross-departmental project built on a foundation of staff and community input, with additional opportunities for more input coming in 2023
- Development of Library Safety Specialist staff role, rather than contract security.

Hamline's new building's design incorporates the community's desire for a library that uniquely reflects the **cultures of the neighborhood** today while including **elements of its history**.

- The existing building's preserved stone arch entryway leads to a meeting room
- Salvaged brick is used in the interior
- Salvaged wood from the existing building's stage is used in the community room.
- The diamond brick pattern was discovered in the existing library's original 1929 draft documents and is now giving a unique look to the new library's exterior.

### **Update and Next Steps: Hamline Midway**

- Through a citizen petition, the Hamline Midway Library has been placed on the National Register for Historic Places.
- Being listed to the National Register of Historic Places does not prevent us from moving forward with a new building.

### **Update and Next Steps: Hamline Midway**

- The library is now required to complete a environmental assessment that will provide a brief analysis and overview of the environmental impacts for the project, which we have begun.
- Library is working closely with a number of city departments to understand how the designation might impact our process.
- The city is committed to following the required process and committed to a transformational new building for the Midway neighborhood.





### **Update and Next Steps: Hamline Midway**

- While we are following the process outlined for us in this project, we are also preparing the existing building for construction.
- This includes completing construction documents, closing to the public, packing and moving the collection, and other tasks to de-commission the building.
- We're moving ahead with both of these processes in order to make the best use of the available city funds, minimize escalating construction costs and deliver this new library to residents as soon as possible.
