Dear Legislative Hearing Officer,

I am writing this letter as a neighbor in response to the license application by DWD Group LLC, doing business as Gather Eatery & Bar, which has been operating as Billy's on Grand.

My wife and I moved next door to Billy's on Grand in August of 2022, and have nothing but negative feelings towards the establishment since arriving. We have lived in multiple major cities before Saint Paul and knew the potential of "bar noise" prior to signing our lease at our location. Needless to say, our experience living next to Billy's on Grand has been like nothing we have ever seen or experienced before and has reached well beyond your typical "bar noise".

My wife and I have called the police countless times since living here due to reckless firearm discharges, gun shots, domestic disputes, verbal altercations, reckless driving, patrons loitering beyond operating hours, patrons playing excessively loud music from their cars while they loiter, open drug usage, and witnessing public urination to name a few offenses.

If the city of Saint Paul communicated with the Saint Paul police department, the SPPD would be able to provide a sufficient amount of evidence to prove Billy's on Grand is an issue.

Billy's on Grand is bringing no value to this neighborhood and does not belong here. The amount of criminal activity and mischief has skyrocketed in this neighborhood since the new ownership group has taken over and community members do not feel safe in this neighborhood. The amount of police calls due to the patrons of Billy's on Grand should be enough evidence beyond measure that this business cannot go on as is. There has been evidence of an increase in gun violence in this neighborhood directly related to this establishment. The city of Saint Paul already knows what a nuisance and safety liability this business is causing. Accepting the liquor license for Billy's on Grand would be accepting this neighborhood to continue on a downward path. The police have been called hundreds of times in the past few years and this business has been allowed to stay open and carry on. Someone was shot and killed on Grand Avenue in August of 2020, directly related to individuals from Billy's on Grand.

When is enough enough? Do more people need to be hurt? Does someone else need to be shot?

Please let the neighborhood live in peace, and do not accept the continuation of a liquor license at 857 Grand Avenue.

As a last note, someone with an automatic firearm shot multiple rounds through the patio and front windows of Billy's on Grand last night, in the early hours of May 7th.

I am pleading with you to make this madness stop! I live here. I have witnessed, single handedly, day in and day out, better than anyone else, the dangerous and destructive behavior that is a result of the business at 857 Grand Avenue. This is a residential neighborhood that is

wreaking havoc on innocent community members. Please help.

I'm writing this on Sunday afternoon after we were awoken (yet AGAIN) at 1:30am by another flurry of gun fire in front of 857 Grand, presently known as Billy's on Grand. Billy's front window was shot out and is currently covered with gray sheets of plywood. Luckily, yet again, no one was injured or killed. How much longer before Billy's and the city's luck runs out and the headline changes to injury or death?

This establishment and ownership CANNOT be allowed to continue to function in this manner. They CANNOT continue to be allowed to be a nuisance and blight on this otherwise upscale neighborhood. They CANNOT be allowed to stay open past midnight. They CANNOT continue to be permitted to have DJs or live bands/music. They have demonstrated numerous times in the last two years that their client base cannot behave as law abiding, civil people.

I was nearly struck down by a stray bullet last June from a probable customer of Billy's. I can't walk into my kitchen without pause, reflection, or memory (and sometimes fear) of that night.

I have owned a home here along Grand Avenue for twenty-four years. I have been a nearly life long Crocus Hill and Mac-Groveland resident. No more. I'm finished. I'm tired. I am now leaving Saint Paul strictly because of this establishment, how it continues to be run, and how the city seems to refuse or be able to take definitive action.

Fix this soon or the blood will be on your hands.

Regarding licensing of Billy's on Grand:

The Billy's experiment has clearly failed, regrettably for the people who backed it with their money and hard work. Now the City of St. Paul needs to stop wasting valuable human and financial resources, not to mention time and, last but certainly not least, the neighborhood's patience, in trying to revive it.

This process has been marked by numerous offenses and astonishments—Billy's makes sure there's always some new outrage to complain and worry about—and when planning to write this note I had assumed the latest one would be the situation described in a reader's letter to the *My Villager* newspaper on 19 April. Specifically, this letter told of the reader's family having to be *frisked* on entering Billy's after 9pm on a Sunday night.

The idea of undergoing frisking to enter an establishment in the Summit Hill neighborhood would be hilarious if it weren't utterly appalling and frightening. The ironic part is, I'm all for it: No one knows better than the Billy's folks whether their customers need frisking to maintain safety on the premises. But that's not the issue: The issue is this: *What on earth is a place like that, whose regular customers can apparently turn out at any time to be dangerous criminals, doing in this neighborhood?!?! It's absurd, it's shocking, and it's deeply offensive...and how about dangerous?* There is no place for any establishment with that profile on Grand Avenue, from Dale Street all the way to St. Thomas.

Whatever Billy's is doing to attract these patrons—and I have no idea what that might be—it has to stop, and we've been hammering away at this situation long enough to realize that the only way to make it stop is to take away their license to operate. Obviously, this is not an appealing, sustainable way for a mixed-use neighborhood to deal with its businesses, but enough is enough.

Like I said, I had assumed the frisking story would be the most recent outrage when I got around to writing this note, but in the meantime Billy's came up with another: Within the last 36 hours some clown stood in front of the place and fired shots into it; the police found bullet holes in the windows. (Note that the previous report of shot-up windows involved my neighbor's kitchen, on the *third floor*.) Were those shots fired by the people who own the bar? Of course not. But somehow this place consistently attracts this sort of miscreant. No other establishment in the neighborhood has operated as such a magnet for obnoxious and dangerous misbehavior.

This has gone on long enough. The idea of living in fear of my own neighborhood is totally unacceptable, and, whether it's true or not, the City is giving the impression that it's simply dawdling, reacting to some kind of vague pressure from some vague parties. Please stop wasting our time and yours, and revoke the operating licenses for Billy's on Grand.

Dear Councilmember Noecker:

I am writing to express my opposition to the proposed liquor license for Billy's on Grand ("Billy's"). I am asking that you vote against granting Billy's a liquor license.

I am a long-term St. Paul resident. My wife and I have owned our property at 796 Summit Avenue since July 1996. I've been a St. Paul resident since 1987.

As you are likely aware, there was another incident involving the actual property of Billy's overnight Saturday (actually, approximately 1:25am on Sunday, May 7<sup>th</sup>) where shots/bullets were fired into/at Billy's. I am a nearby neighbor (one block away) and heard between sixteen and twenty gun shots.

This latest incident comes only four weeks after an exchange of gunfire occurred directly in front of my property (corner of Summit Avenue and Avon Street, FORTY FEET FROM MY FRONT DOOR) on Friday, April 7<sup>th</sup>. That exchange (estimated at as many as forty shots) resulted in a bullet going through the bedroom window of my neighbor's home.

When discussing the April 7<sup>th</sup> incident with the owner/managers of Billy's on Grand, they pushed-back

that the incident had anything to do with their establishment. While this defense of their establishment in the April 7<sup>th</sup> incident cannot be refuted; the correlation of gun related incidents, at/around bar closing time, in very close proximity to Billy's cannot be dismissed. Law enforcement officials that we (neighboring residents) spoke to following this April incident essentially said the same, that while there's certainly dramatic increases in gun related incidents nearby the Billy's property – typically at/round bar close, the April 7<sup>th</sup> incident could not be directly attributed to Billy's.

The incident from early morning May 7<sup>th</sup> is absolute proof that Billy's and Billy's patrons (albeit – a very small percentage of the patrons) – are a significant (if not the primary) source to the escalated gun related incidents that occur at/around bar close time in this one-block area.

Past incidents (gunfire related and other violence) attributed to Billy's (while under the group applying for the liquor license) are a matter of public record. These past incidents, combined with the two incidents in the past month, cannot continue to be tolerated by the civic leaders of St. Paul.

Again, please vote against granting Billy's a liquor license.

Since moving into my apartment, I have had to deal with loud music, witnessing clearly intoxicated individuals leave Billy's and drive, and most importantly I **have had to deal with repeated gun violence.**

I live in a first floor apartment, with my bedroom looking out onto the street. This last Saturday night, I had to lay on the ground of my bedroom after I heard repeated gun shots right outside. Thankfully, I guess for my sake, the shots were going away from my apartment this time.

I've had to, again, call 911 on this establishment while also hoping that no bullets flew through my window and either strick me or my pets. I see from my neighbors, that they are not so lucky and have had windows shot out or near misses in their own homes. How long, until a by-stander gets struck? All because the city refuses to take swift action against a poorly run establishment.

**Enough is enough**, this bar has had its 3 strikes, and then some. I am sick and tired of fearing that my apartment, or one of my neighbors apartments, is going to be struck. This is an unsafe establishment, and the data clearly shows that the new ownership is not taking responsibility for the actions of their patrons.

These types of incidents do not happen nearly as frequently, if at all, at any other location on Grand Avenue or in the surrounding neighborhood.

I should not have to fear for my safety, due to one location, **in my own home.**

If this were occuring at other establishments, or locations, it would be shut down. The bar is a repeat offender, and the danger that it poses is clear and obvious to the public.

I am so tired of speaking to the police when they show up after a gun has been shot off, time and time again. I beg that you do not renew this location's liquor license, and work towards shutting this establishment down.

Sunday May 7, 2023 around 1:30 a.m., we reported hearing what sounded like an A-15 assault rifle being fired on Grand Avenue.

We have lived in our condo for 26 years and despite minor annoyances, we have never seen anything like the violence, bullets, disrespect for the law, and just plain danger that occurs most evenings at Billy's on Grand.

This is since the new owners/manager acquired the property.

Grand Avenue, Summit Avenue, and Crocus Hill have long been a sanctuary not only for residents, but also for others. Visitors of all races, incomes and backgrounds, people from all over the state and the country, used to enjoy evenings in this neighborhood. Small, friendly shops and cafes flourished. Now, the Grand/Victoria area is often deserted after 9 p.m.

Except, of course, for Billy's on Grand.

In our time here, this wonderful neighborhood used to offer respite at a time when it has never been more needed.

However, the record shows that present ownership of Billy's is attracting people of criminal intent.

Question: Why did staff refuse entrance to the business after reporting a fight?

I am copying below an email I sent to Councilmember Noecker on April 3:

*Dear Councilmember Noecker;*

*I'm writing to express my concern regarding the license that Billy's on Grand has applied for. based upon the license application specifics, as published on the ENS dated 3/24. Most concerning to me are:*

- A closing time of 1 am. This is inappropriate for a bar in a primarily residential neighborhood, as the past issues associated with Billy's has proven. There is no reason that this is warranted in an area that is not an entertainment district and where most surrounding businesses close much earlier. In terms of establishments serving liquor, the nearest ones are Salut (closing at 10 pm on weekends) and Red Rabbit (closing at 11 pm on weekends). Until Billy's is able to demonstrate that they can run a compliant business and exercise appropriate controls over their patrons, a similar closing time would be a good starting point.*
- Liquor service on their patio. As above, this should be even more sharply curtailed, given some of the behaviors that have been witnessed there, and the noise potentially generated by raucous patrons, as witnessed in the past.*
- Entertainment. As above. The existence of entertainment speaks to a clientele which is there to drink, rather than to dine. The crowds potentially attracted by this, the noise that would certainly be generated, and again, the previous issues related to this, speak to denying this aspect of their license until they demonstrate that they can operate responsibly and exercise appropriate controls over their customers.*

*Absent any details around their plans vis a vis security (both inside and outside the premises) it seems doubly important that they are allowed only an earlier closing hour until a significant trouble-free period of time might justify a later closing time.*

Why would this be allowed for a known problem business which apparently is not capable of ensuring the safety of its customers and neighbors during the course of normal business hours, much less a situation like this with literally thousands of people--including children--present?*

This is a business that does not belong on Grand Avenue with its present business model, and the litany of issues and violations has gone on for way too long. The owners are clearly either unable or unwilling to take the measures needed to control the behaviors of its clientele which have repeatedly endangered the lives of nearby residents and significantly impaired the livability of a primarily residential neighborhood and the nearby low-impact businesses. At this point, they should not have a liquor license, much less be allowed to sponsor a beer garden at Grand Old Day nor be given the sound level variance that goes hand in hand.

Dear Councilmember Noecker:

I am writing to express my opposition to the proposed liquor license for Billy's on Grand ("Billy's"). I am asking that you vote against granting Billy's a liquor license.

I am a long-term St. Paul resident. My wife and I have owned our property at 796 Summit Avenue since July 1996. I've been a St. Paul resident since 1987.

As you are likely aware, there was another incident involving the actual property of Billy's overnight Saturday (actually, approximately 1:25am on Sunday, May 7<sup>th</sup>) where shots/bullets were fired into/at Billy's. I am a nearby neighbor (one block away) and heard between sixteen and twenty gun shots.

This latest incident comes only four weeks after an exchange of gunfire occurred directly in front of my property (corner of Summit Avenue and Avon Street, FORTY FEET FROM MY FRONT DOOR) on Friday, April 7<sup>th</sup>. That exchange (estimated at as many as forty shots) resulted in a bullet going through the bedroom window of my neighbor's home.

When discussing the April 7<sup>th</sup> incident with the owner/managers of Billy's on Grand, they pushed-back that the incident had anything to do with their establishment. While this defense of their establishment in the April 7<sup>th</sup> incident cannot be refuted; the correlation of gun related incidents, at/around bar closing time, in very close proximity to Billy's cannot be dismissed. Law enforcement officials that we (neighboring residents) spoke to following this April incident essentially said the same, that while there's certainly dramatic increases in gun related incidents nearby the Billy's property – typically at/round bar close, the April 7<sup>th</sup> incident could not be directly attributed to Billy's.

The incident from early morning May 7<sup>th</sup> is absolute proof that Billy's and Billy's patrons (albeit – a very small percentage of the patrons) – are a significant (if not the primary) source to the escalated gun related incidents that occur at/around bar close time in this one-block area.

Past incidents (gunfire related and other violence) attributed to Billy's (while under the group applying for the liquor license) are a matter of public record. These past incidents, combined with the two incidents in the past month, cannot continue to be tolerated by the civic leaders of St. Paul.

Again, please vote against granting Billy's a liquor license.

Legislative Hearing Officer,

I strenuously object to the issuance of a permit under this application to this business to serve alcohol at that location. My reasons are as follows:

1. The current operators of Billy's (DWD Group) are operating under another entity's license (RPMJ Group) and are applying for their "own" license.
  - a. The current operators of Billy's that are operating have been found non-compliant under current license conditions and have been fined twice. These hearings, administrative law judge proceedings, city council meetings, etc... take a very very very long time. (OAH 71-6020-38398)
  - b. They have had two more "occurrences" that are being, or should be, brought forward as violation of license conditions that occurred during the very very very long processes for the first two incidents which both drew fines from the City council. Based on my understanding and police reports:
    - i. one was for refusing police entrance to the business to investigate after an incident/assault;
    - ii. the other was 18 June 2022 after two customers who had begun a confrontation in the facility left the specific confines of the business itself, exchanged gunfire with many rounds being fired immediately outside the business (nine casings from 2 different weapons) and then fled and to my knowledge were never apprehended even though the police could view both of them on video from inside the bar and leaving the bar. One of the rounds fired went through the kitchen window of the building that I live in and narrowly missed one of my neighbors. (pictures attached) (SPPD Case No. 22-107998)
    - iii. It is my understanding that if they are granted a new license with their own operating conditions the two outstanding license violations would be associated with the old license or possibly even just "go away". Unacceptable!
2. There have been several incidents of gunfire in the late evening hours since the incidents described above. The most recent was on the early morning hours (1:25AM) of 7 May 2023 when an incident described by police in their initial comments of their continuing investigation as:

*The investigation into this incident is on-going. The incident has been assigned to the gang unit for further investigation.*

*So far we know that our officers were dispatched to the area of Grand/Avon just before 1:30am on 5-7-23 on the report of multiple shots fired. There was a large crowd of people in front of Billy's on Grand. Officers did not locate anyone who was injured in the incident. Two windows at Billy's on Grand had been broken and it is believed to be caused by the gun fire.*

*Preliminary investigation is that the rounds were fired somewhere outside on/near Grand Ave.*

*It is unknown at this time what lead up to the shots being fired, but that is something our gang unit investigators are working to try to determine.*

*Officers recovered video and other evidence that will be reviewed and process[ed] by investigators in the gang unit. No suspects at this time, but again the investigation is on-going.*

*I hope this helps answer some of your questions. Feel free to reach out with any additional questions or concerns. Thank you.*

- a. In addition to the bullets that shattered windows of Billy's own building, the following morning a resident directly across the street from Billy's found a bullet hole in a window of her residence. Picture attached. While the investigation is continuing it indicates that gunfire was going in both directions – toward Billy's (shooting out windows as indicated in the above police communication) AND away from Billy's penetrating the window and residence directly across the street.
  - b. Reports from those awakened by the gunfire at 1:25AM report that it was "automatic" gunfire (machinegun like). This is commonly observed when pistols are modified to alter the "sear" that allows semi-automatic pistols to fire in the same manner as a machine gun, often with extended magazines containing 30 rounds of ammunition. As stated above this incident has been referred to the "gang unit".
  - c. The SPPD have now stationed a monitoring trailer and camera surveillance unit in front of Billy's that is perhaps necessary under the current conditions and operations of Billy's but represents another cost for the City and is emblematic of the operation of Billy's as the nexus of violence, police response, and cost to the City and impacts to the neighborhood, the residents and other businesses as a result of and associated with the operation of Billy's.
3. They currently have uniformed unarmed security on site, the off duty Ramsey County deputies that formerly were there about a year ago are no longer - they refused to continue providing security. They frisk – pat down, customers entering after 9PM. They have private security there as a condition of their license as a consequence of conditions imposed on them as a result of multiple prior incidents at Billy's under the current owners operations. That hasn't seemed to help much. The incidents continue.
4. In my opinion, the reason the shootings are happening outside of the bar is because they frisk and search patrons coming into the bar, so when they get into a dispute inside, they take their dispute outside, get their guns out of their cars, and start shooting it out.
5. The operators of Billy's have steadfastly tried to deflect the incidents that have occurred as happening "outside of their premises". In their view - their operation creating the environment and creating the conditions in our neighborhood described above is not being anything that they can be held accountable for. This is false, wrong, disingenuous. Their operation has been the nexus for the incidents cited.
6. The hearing examiner MUST review the prior findings by the prior administrative hearings and findings. These are FACTS and findings that must be considered in this process.
7. The hearing examiner MUST request from the SPPD all police reports including ongoing investigations since the last administrative hearings to get the facts and full scope of the incidents and the number of incidents that the police (and the neighbors in our area) have had to deal with and endure as a direct result of the operation of Billy's over the past 2 years.
8. During a hybrid in person and zoom meeting at the Western District SPPD offices on 15 July 2022 I participated in the meeting via Zoom (pandemic conditions) and directly asked Mr. Spearman why he had to be open between the hours of 11PM and 2AM. His two responses were:
  - a. "We just want to be treated the same as other's (a reference to other licenses in St. Paul that allow the sale of alcohol after 11PM); and
  - b. "We are a high volume business"

His first comment (a.) seems to completely disregard the requests, feedback, demands from the residents in the neighborhood. His second comment (b.) indicates that the profit that the operators hope to gain between 11PM and 2AM justifies the violence, gunfire, police response and other unacceptable conditions the neighbors are expected to endure so that he can gain profit from alcohol sales from 11PM to 2AM.
9. The operators of Billy's, in the background of all that has occurred above and the repeated requests from the neighbors and recommendations from the police to not offer events that create the Nexus for

late night violence, gunfire, noise and disturbance in our neighborhood have continued to do just that. A posting from the internet for a recent event:

The operators of Billy’s have shown no ability to control the violence that has become associated with their operation and have shown no willingness to modify their operations in spite of continued violence and gunfire.

There have been assertions of racism and prejudice against my neighbors and others in the community who have spoken out against the operations of Billy's over the past two years by the operators of Billy's. These unfounded assertions have appeared both in print and broadcast media. I am offended by those assertions. The issues enumerated above are FACTS. Bullet holes are bullet holes, spent casings on the curb are real and tangible. The assertions of racism are a disingenuous attempt to deflect the responsibility for the serious issues outlined above.

**My strong recommendations:**

- A. Do not issue a new license at this time to DWD Group LLC, doing business as Gather Eater & Bar until all open incidents associated with the current operation under the current license have been fully processed through DSI, the city attorney, and any office of administrative hearings and the City council. These issues are serious and the refusal to allow police to enter the facility may itself result in revocation of the existing license. The operators should not be allowed to evade responsibility by attempting to get a completely new license and not be held to account for their past violations of an existing license they are operating under. **Their request for a new license at this time is a ploy to avoid revocation of the existing license that Billy’s is operating under due to the past violations and penalties and the pending actions discussed above. It is my understanding that under City licensing**

**the revocation of the existing license would result in that physical location not being able to receive a new full liquor license for 15 years. The outcome of fines, additional conditions, and potential revocation of the current liquor license as a result of administrative and City council process related to items 1. b. i. and ii. above should be allowed to process through the system. The issuance of a "new" license should not circumvent the process and allow them to evade the consequences of their prior, and current operations of the facility.**

- B. If after going through the hearings and actions related to the prior incidents outlined above the City does not revoke the existing full liquor license for the current operators of Billy's (this would be a tragedy and an abdication of their role and duty) then:
  - a. The city must put additional restrictions on the license conditions and among other conditions restrict the operation to close at 11pm;
  - b. the existing license should not be renewed at the time it comes up for renewal; and
  - c. a new license should not be issued at that time.
- C. If in spite of our objection to the issue of a new license - if the council would feel pressured into making that very unfortunate and inappropriate decision, the license should be greatly restricted from the license that currently exists to conform to the character and nature of the neighborhood:
  - a. considering the past issues of the operation that location should focus on food and have a beer and wine only license.
  - b. considering the noise and disruption of the operation on the mixed business residential nature of our neighborhood an 11PM end of beer and wine services to its patrons is most appropriate.

I look to the hearing examiner, DSI, and the City Council to show bold and clear leadership on this issue to show concern for the residents and the other businesses in our area and to restore and maintain the feeling and reputation of Grand Avenue and the greater neighborhood as a safe and enjoyable place to be. In addition, for the residents in our area, we want to feel safer walking our streets, being out at night, and going to the window and not fear catching a stray bullet.

Ample evidence shows that **the operators of Billy's (DWD Group), currently operating under a license held by RPMJ Group, should be denied their own license.** I draw this conclusion based on the record of violations and decades of association with this neighborhood. I currently live at 57 Avon St. S. #31 and Billy's can be seen from my kitchen window.

Under the operation by DWD there have been a string of disturbances that are directly related to the behavior of patrons (including gunfire) and an alleged assault in the establishment. The owners have been fined twice for being non-compliant under license conditions. However, serious issues continue.

Around 1:26 am on 7 May 2023 my husband was awakened by rapid gunfire and viewed a police vehicle outside of Billy's. Understand, there are now bullets being discharged in an otherwise (formerly) peaceful neighborhood. The gunfire is directly associated with the patrons of Billy's on Grand. And now there is a police monitoring station directly across from Billy's. None of this is normal.

I ask – among the numerous restaurants and bars along Grand Avenue, between Lexington and Dale, are there recorded incidents of firearms being discharged or the need for police monitoring stations?

CM Noecker is staying in close touch with the police department as the investigation into the incident proceeds. Currently, the incident has been assigned to the gang unit for further investigation.

It is unknown at this time what led up to the shots being fired, but that is something the SPPD-Gang Unit investigators are working to try to determine. Officers recovered video and other evidence that will be reviewed and process by investigators in the Gang Unit. There are no suspects at this time, but again, the investigation is ongoing.

Before deciding whether to grant a license and whether to impose any conditions on that license, our licensing staff will be holding a public hearing on June 1. I am cc'ing our licensing team so they can take your concerns into account.

Public safety is a priority for CM Noecker and our entire office and we are very concerned about this recent shooting. It is unknown at this time what led up to the shots being fired, but that is something the SPPD-Gang Unit investigators are working to try to determine. Officers recovered video and other evidence that will be reviewed and process by investigators in the Gang Unit. There are no suspects at this time, but again, the investigation is ongoing.

Before deciding whether to grant a license and whether to impose any conditions on the application submitted from Mr. Wes Spearman for Gather Eatery & Bar (857 Grand Avenue), our legislative code requires notice and an opportunity to be heard. This hearing has been tentatively noticed for June 1, 2023. At this time, our licensing staff will be holding a public hearing and members of the community can participate either in person or through written correspondence at

[lh-licensing@ci.stpaul.mn.us](mailto:lh-licensing@ci.stpaul.mn.us). This is the proper venue for your concerns to be heard and considered.

If you have questions about your participation at the licensing hearing or would like to share your additional concerns, I am cc'ing our licensing team so they can take your concerns into account.

After the licensing hearing, the Legislative Hearing Officer will prepare a recommendation. This generally takes about two weeks. When the report is complete, the recommendation of the Legislative Hearing Officer will be placed on the City Council agenda so that City Council can consider the license application, the report of the Legislative Hearing Officer and any recommended conditions.

At this point, Councilmember Noecker and her colleagues will be acting in their quasi-judicial capacity. As a result, she cannot take a position on this matter or have private conversations as our legislative code requires that City Council consider the record before it.

If you have questions about the prior process and procedures, we encourage you to refer to RES 23-417 and [view the video](#) from the City Council meeting which lays out the next steps available to the City Council.

I've lived in the Summit neighborhood for 28 years; I've always felt proud of where I live, and I feel it was a great place to raise my three children.



I am writing in response to the application for a license renewal for Billy's on Grand.

I have been a resident of this neighborhood for the last 27 years. We have been in our current house for the last 19 years. Prior to Covid, this had been a wonderful, walkable "lifestyle" neighborhood with no concerns for safety. I can sadly say this is no longer the case. Billy's and it's clientele has contributed to the demise of this Grand avenue area. We can no longer walk at night on Grand - there are stabbings and shootings (we can hear the shooting from our home in summer with the windows open), drag racing, drunken screaming at bar time, etc. We used to frequent Billy's prior to this ownership, we would bring our kids, we would bring people from out of town to Billy's. We enjoyed years on the patio. Now we are not welcome. My wife and I have lived in Saint Paul just over two blocks from Billy's for more than 30 years. In that time, we raised a family and frequented Billy's on Grand for casual drop-in meals, for after-tennis evening beers, for high-school hockey fundraising events, and for celebrations with friends and family. In the past we have also personally rented the back room more than once for celebrations of a graduate degree and of a neighbor and good friend's birthday.

Unfortunately, the new owners have demonstrated time and time again that they don't care about the neighborhood that they should be serving, but only about their own personal interests. The bar has become a hangout for drug dealers and gang members, with all the unsavory behaviors and illegal activities that come along with it. Frequent fights, obscene language, shouting, loud vehicles, and gunfire at and near the establishment has cast a pall on the neighborhood and on all the solid, safe, conscientious businesses that line Grand Avenue.

I'm sure the owners will deny that their establishment is responsible, but as a long-time resident of the area it is easy to see the impact that their management has created. We have personally heard the increase in gunshots at and near the establishment as well as in the nearby surrounding area. I'm reaching out to you for relief from the ongoing issues with Billy's on Grand.

As background -- my family has been associated with this patch of real estate since the late 90s. Home ownership includes 2 different properties on Lincoln Ave and our current residence -- 57 Avon St. S. #31. The area has been an ideal urban location, which historically has been safe and vibrant.

The current operation of Billy's on Grand has changed that situation. They have been disappointing neighbors and have brought gunfire to our location. You're aware of the string of problems associated with this business. The most recent was gunfire at/about 1:25 am Sunday morning (7 May). I was awakened by what -- in sound sleep -- seemed like rapid knocking on our door. That seemed unreasonable given we live on the 3<sup>rd</sup> floor of a condo building. Quickly, I realized that gunfire woke me up. I went to the kitchen window to see a police car blocking Grand Ave., with lights flashing. Indeed, there was gunfire and it was likely from a modified gun to allow rapid fire. This incident is not the first gunfire associated with Billy's on Grand -- in fact a bullet came through a window in the adjacent building.

The Billy's on Grand experiment has failed. There is no evidence that the measures taken by the operators have changed the situation. It's not more safe.

You make comments about gunfire at El Alamo...they are pasted below. I hope those feelings apply to the situation in our neighborhood.

Please do all in your power to pull the license from Billy's and certainly do not support and new license with a fresh name. That will not change the situation. Ample time has passed for measurable change in the behavior of their patrons. I ask -- among the numerous restaurants and bars along Grand Ave. between Lexington and Dale are there recorded incidents of firearms being discharged or the need for police monitoring stations (currently in place in front of Billy's)?

Please help stop the crime and violence in our neighborhood. Please apply your values associated with El Alamo to our situation. Pull the license and do deny a new license. Something is quite wrong with the

operation of Billy's.

For all of us living in the Summit University / Summit Hill neighborhood, we have been concerned with the increase of gun violence on Grand Avenue. As recently as last Saturday, there was shooting originating from Billy's on Grand. Shots have been associated with Billy's late night dance club hours. Our veterinarian at St. Paul Pet, Dr. Eric Ruhland who lives on Summit behind Billys, had a bullet go through his bedroom window during one of these incidents.

Analogously, in our experience in Colorado, when CO legalized marijuana, the city of Breckenridge made the call that all marijuana retailers needed to relocate off main street - this was difficult for the one medical marijuana storefront at the time, but now, all dispensaries are on airport road. I have no issues with and in fact welcome legalized

marijuana, but feel that for a family-friendly shopping street, is appropriate to move dispensaries off main street. Similarly, St. Paul needs to ensure there are guidelines for business activity across St. Paul.

We need to help our St. Paul leadership and government align around the same decisions regarding Grand Avenue. It is a residential, retail, family-friendly street, and we need to have policies to protect citizens, regulating businesses as required. If Billys is unable to run its restaurant with the safety of all in mind, we need the city to govern it through its business licensing policies.

Dear Licensing Board: As a long-time resident of 1052 Lincoln Avenue, Saint Paul, I write to oppose the issuance of a new liquor license for Billy's on Grand, or at a minimum, a restriction on Billy's operating hours to no later than 10 PM. As you are no doubt aware, Billy's on Grand has become a local magnet for criminal activity, with drug-dealing going on in the parking lots—in broad daylight—and with Billy's employees more interested in hanging out with the dealers than serving patrons. Gunshots both on and around Billy's property are now a routine occurrence.

While the owners of Billy's have disclaimed responsibility for the violence, certain facts cannot be disputed:

1. Post-pandemic, most bar / restaurants in the Grand Avenue area (e.g., Groveland Tap, Red Rabbit, Iron Ranger) close much earlier than pre-pandemic (typically around 10 PM), primarily due to a shortage of qualified employees willing to work late hours.
  - a. From personal observation, Billy's has not solved the "lack of qualified employees" problem; rather, it simply chooses to operate late into the night without sufficient qualified employees.
  - b. The result is over-serving of patrons, a lack of adequate security, and a general sense that Billy's is out of control in the late-night hours.
2. Because most bars / restaurants now close earlier than in the pre-pandemic era, most patrons have adjusted their habits to accommodate this new reality. Only hard-core drinkers and people looking for trouble are out and about past midnight, looking for a place to get drunk and use drugs.
3. Because there are fewer places open to accommodate late-night mischief, Billy's receives a concentration of the criminal element as its patrons in the late night hours.
4. The vast majority of bars / restaurants on Grand Avenue have figured out how to stay in business without serving patrons long past 10 PM. There is no reason that Billy's cannot do the same.

In sum, while I regret that a Grand Avenue institution that I used to regularly patronize has morphed into a dangerous gang bar, that sadly is the case. The current owners of Billy's have proven themselves incapable of maintaining an orderly place of business; they cannot (or will not) control what goes on in their establishment and in its immediate surroundings (parking lots, alley, etc.). Billy's on Grand is now a blight on Grand Avenue and the surrounding neighborhood. It should not be granted an new liquor license or, at a minimum, it should have its hours of operation severely restricted, to no later than 10 PM.

When I moved to Grand Ave in 2020, I chose to live in this area due to the safety of the community. I now am afraid to be outside of my home after the midnight hour with the almost guaranteed sound of gun shots almost every Friday & Saturday night on the street. There are nights that I hear so much fighting after bar close that I don't sleep in my own bed for fear that a bullet may ricochet into my window as I am on ground level. I know that sounds aggressive but it is the truth. I no longer walk home from work if I am working a closing shift and I only work a few blocks away. Friday & Saturday nights I tend to turn down / off the tv just to listen to the fights escalate that usually end in gun shots in the neighborhood.

I don't believe that Billy's should lose their complete license as I do not fear the day traffic and is a staple to the Grand neighborhood. I do however believe that they should shut down at midnight as that is when the "witching hour" tends to begin. The crowd doesn't seem to be able to handle themselves / the liquor after that hour. Nothing good comes of the night at that hour but violence.

I am writing concerning the Liquor On Sale license application for DWD Group LLC for the property at 857 Grand Ave; License Number: 20230000453. I live at 63 Avon St. S. with my wife and my daughter. In the past 3 years we've experienced several shootings and countless assaults, most of which have been tied directly to patrons of Billy's on Grand.

In the past year alone:

3/5/22 Male shot in the chest. Suspect chased a witness down in his car and crashed into her at Milton and Grand.

3/25/22 Woman assaulted, dragged from her car and beaten. Avon and Grand

4/3/22 Woman assaulted by man at Victoria and Grand

4/8/22 Shots fired at Avon and Grand

5/15/22 Person assaulted Victoria and Grand

6/19/22 Gun battle on Victoria and Grand. Bullet through window at 51 Avon St. S. narrowly missing my neighbor in his kitchen.

8/5/22 Woman assaulted at Billy's on Grand

8/19/22 Woman assaulted at Billy's on Grand

8/21/22 Gun battle on Grand Ave continued in the alley between Grand and Lincoln.

10/10/22 Weapons Discharge Lincoln and Victoria

11/5/22 Weapons Discharge Grand and Victoria

4/7/23 Summit and Avon 30-40 shots fired. Bullet through resident's window

5/7/23 Gun battle Victoria and Grand. Bullet through resident's window

That's 8 shots fired incidents within a block of 857 Grand within the past 14 months. Is Victoria and Grand the most dangerous intersection in St. Paul?

At an April 2022 Summit Hill Association meeting, former Western District Commanders Josh Lego and Jennifer Corcoran were in attendance and gave evidence that other bars with similar issues of shootings and violent assaults such as Ted's Recreation on Larpenteur, voluntarily changed their closing time to midnight and the issues were quickly resolved. I asked Mr.



Spearman if he would be willing to close at midnight rather than 2am. He stated that he was willing to make that change. Later that summer at another SHA meeting, Mr. Spearman said he would change his closing time to 1am. I'm not sure if he ever followed through on that promise, but recent Facebook posts advertise that they are currently open until 2am. And the problems continue.

There is an outstanding violation against the current liquor license which is the 3rd violation since Mr. Spearman took over running the business. That violation has never been heard by the City Council and no action has been taken on it. That violation should be heard before a new application is considered.

Mr Spearman has consistently shown that he is unwilling to work with the neighbors who live near his business or follow the recommendations of the Summit Hill Association or the St. Paul Police Department. His business operations present a clear danger to the neighborhood and it is unfair to the residents and other businesses who live and operate here.

For these reasons, I oppose the application for Liquor On Sale license for DWD Group LLC.

I'm writing in opposition to the request by DWD Group LLC for a liquor license application for Gather Eatery & Bar at 857 Grand Avenue, St. Paul.

My name is Kevin Johnson. My wife Jean and I reside at 51 Avon St. S, #23. We moved here in late 2017 from Hutchinson, Mn. We were delighted to find a vibrant residential/commercial neighborhood to call home.

The convenient proximity of auto service, grocery, hardware, dental care, eyewear, pharmacy, gift shops, bookstores, on and off-sale liquor availability, a wide variety of other retail and service shops, and so many dining options made this choice of residence an easy one.

Many of the residents of the nineteen-unit condo association where we live have become good friends.

Our second floor condo overlooks Grand Avenue. Our front living room windows face east, with a view down Grand toward Brasa, Punch Pizza and Caribou Coffee.

Our kitchen windows at the rear of the building face west toward Victoria Street, with a view of Bread & Chocolate, Victoria Crossing, and Billy's on Grand.

There are fourteen buildings along Grand Avenue between Avon and Victoria. While businesses are an attractive feature, as I've already made clear, eleven of the fourteen buildings are places that we and our neighbors call home.

For the majority of the business day, there is nothing unusual about Billy's. Sadly, that cannot be said about it later in the evening, especially during weekends.

After most of the businesses along Grand have closed for the day, Billy's begins ramping up, for lack of a better term, as a nightclub. The food service ends. Alcohol does not. Those already there continue to socialize and drink. New arrivals come to socialize and drink.

Socializing is fine. Drunken socializing increases the likelihood of problems as the documented record of complaints and police responses clearly shows. (Some) socializing combined with drinking combined with guns has been a toxic and dangerous mix. As a result, we've come to dread the approach of weekends.

As events and police records clearly show, the owner of Billy's is operating in a manner and with a business model that is unsafe, and frankly, out of place in any location.

Specifically, management of this establishment over the past two years

has failed to demonstrate it is capable of maintaining a safe environment for residents living in this mixed-use neighborhood.

Does Billy's management train bartenders to refuse drinks to patrons who have had too much already? Are those patrons told to leave if they object to being refused service? Do they leave and come back angry at being refused service? Do they come back carrying a gun?

Does late-night socializing mixed with alcohol build tensions that lead to conflict? We can tell you that we have witnessed those conflicts spilling onto Grand Avenue. From verbal argument, physical confrontation, and escalation to the level of gunfire, we have seen it all.

And it does not remain confined to Billy's immediate premises or small parking area. Which means the requirements and conditions associated with the license application are not capable of addressing the negative impact Billy's is having on this neighborhood we live in.

Whatever the situations are that lead to elevated tensions, even if management enforces the operating requirements associated with having a liquor license, the fact remains that patrons attracted to Billy's for late-night socializing and drinking will continue to pose an unacceptable and elevated risk to the safety of those of us living here.

In fact, during the most recent incident of gunfire early on Sunday May 7, the lives of Billy's own staff were in jeopardy as bullets crashed through one of the windows overlooking their patio along Grand Avenue.

Operating 'as usual' guarantees more of the same outcomes. If nothing changes, nothing changes. Our experience is that Billy's has created an environment with outcomes it cannot control.

The problems have persisted. What additional action can the owner take? If it were within their power to do something that would prevent the dangers from developing, would they not have already done so?

Postscript: The Summit Hill Association conducted an online session Tuesday evening, May 16 regarding Billy's application for a new liquor license. The meeting was for the purpose of gathering public comment prior to making a recommendation to the city of St. Paul.

Mr. Spearman of DWD Group LLC made a presentation outlining plans to re-brand the business. Unfortunately, comments over the lengthy follow-on discussions from Mr. Spearman and several other speakers continue to demonstrate an unwillingness to acknowledge and address the root of the problem.

They want to keep catering to a late-night group that comes to drink and socialize long after food service has ended. DWD Group LLC owners and marketing consultants cite the need for profitability as the reason to continue the practice.

Public Safety and SPPD personnel have repeatedly stated during the drawn-out Billy's deliberations the past two years that disturbances and violence in and near St. Paul drinking establishments are directly linked to late closing hours.

As the May 7 incident appears to demonstrate, DWD Group values profitability even over the safety of their own employees. Working with neighbors and "elevating" the business model rings hollow as a result.

I am currently an SHA board member and offer these comments as a dissenting view to what I feel will be the SHA position on this issue.

There were very significant comments regarding violent behavior and gunfire that cannot be dismissed by stating that:

- the entire country is experiencing these problems
- these activities are occurring outside of Billy's premises
- or as one individual on the SHA put it, perhaps we are not accustomed to the sound of gunfire in the neighborhood
- all of these occurrences were before the current owners took over
- Billy's is a victim and the SPPD is not doing enough to protect them

and finally in the bottom of the 9th inning , the game has changed with the reimagining of Billys while a crime involving a shooting is being investigated.

In all fairness, grant a one year license with closing at midnight. Mr. Spearman will be accountable for adverse activities. Maintain external surveillance cameras. Monitor this closely. The stakes are high. People have had their homes shot at. We need to dissect out the causes for this and sift out the confounding arguments.

This part of St. Paul is becoming a "hot spot" and our complacency cannot be used as an excuse. Someone will get killed as a result of not radically altering this trajectory. We cannot be complicit with that lack of logic and judgement. It is simply misguided with no facts to support it. Weepy pleas for understanding are insufficient. I am tired of the wanton subterfuge being laid on the people who live and work in this community to defend this proposal on the instructions of outside "consultants."

I am writing this communication to express my strong opposition to the extension or renewal of the current liquor license to Billy's On Grand as it currently moves forward.

I am a neighborhood resident who lives within three blocks of Billy's On Grand, as well as a member of the Summit Hill Association District Council. As such, I have been following this ongoing discussion for several months, and even years.

I am strongly opposed to this liquor license at this time, unless significant and enforceable terms and conditions can be attached — including limited hours, significant restrictions, and terms allowing immediate license revocation in the event of any even minor infractions or violations.

The ownership group seeking the license recently gave a public presentation to the SHA Board of Directors, and the Association's Zoning and Land Use Committee, seeking SHA's endorsement for this renewal.

Based on that presentation, as well as recent events within a three-block radius of the business, I am distressed at the ownership's lack of meaningful proposals to acknowledge their role in the current crisis of this neighborhood's violence — and their, at times, even adversarial tone toward neighborhood concerns.

I do not feel their investment on Grand Avenue takes the neighborhood safety concerns with the gravity I believe it deserves.

Four observations from their presentation:

- The ownership group refuses to acknowledge that their business may be a contributing factor in the growing violence and neighborhood disruption within the 3-block radius of their business.
- The ownership group deflects responsibility onto the Grand Avenue neighborhood, its residents, and other businesses, for any problems outside of, or in proximity to, its establishment.
- The ownership bristles at compromising aspects of its business (hours, etc.) that have serious repercussions on the neighborhood as a whole.
- I have not witnessed strong support from the Saint Paul Police Department, or other agencies, to suggest there is a "good working relationship" with law enforcement and other public safety.

The challenges of this neighborhood's violence have increased significantly since the transfer of this business and liquor license. This is not anecdotal. And it is naive to believe that the business practices associated with this liquor license are not contributing factors.

Bullets are being shot into family homes and businesses. Just one bullet, through any neighborhood window, is unacceptable.

The ownership has been operating the business as a nightclub and plans to continue doing so, despite a record of issues and conflict with the neighborhood and law enforcement.

Clientele for this business are frequently idling within a multiple block radius of the business into the late evening and early morning, using illegal substances and violating noise and other ordinances — difficult if not impossible to prohibit or enforce. I know this because I live here, and I walk the neighborhood daily.

Proponents for this license renewal suggest that this behavior, and the recent issues of gunfire through people's homes, cannot be directly linked to Billy's On Grand.

I disagree. That is subjective and misleading at best.

Suffice to say: We don't have stray gunfire when businesses like the Red Balloon, Treats, Mischief or others close for the day. We don't have gunfire when food and beverage establishments with liquor licenses — such as the Lexington, Iron Ranger, Punch Pizza, Brasa or others — close for the night.

I absolutely oppose a carte blanche liquor license for a business that denies it has been a contributing factor in this change.

Liquor licenses in this city are a privilege — and one that is not easily revoked.

Granting a liquor license to this ownership group, given its recent history and record, would do irreparable damage to the Grand Avenue neighborhood.

The purpose of this email is to submit comments to the Legislative Hearing Office regarding the liquor license application noted above during the Public Comment period.

I am NOT supportive of a 1AM close for this liquor license. I am supportive of a midnight or earlier closing. I am aware of the good intentions of the applicant and the intention to “re-brand” although the re-branding, inclusive of family dining, live music, Karaoke, theme party nights and a speak-easy seem to target a variety of audiences and I’m not sure deter late night partying, which appears to be one ( of many) of the issues in and around the restaurant.

Multiple health and safety issues ( well documented by SPPD previously) have correlated to this business establishment, notwithstanding good intentions and change in management style. As recently as 10 days ago there was yet again gun violence that occurred at 1:30 in the morning. A closing time of 1:00 would not prevent patrons from loitering or affiliates of patrons from cruising Grand Avenue at 1:30. A 1:00am closing will have lingerers well beyond 1:00. (Note citizen comments made at SHA board meeting, who are adjacent to Billys regarding activity in the alley behind Billys and on Grand Ave.) While outside activity is not atypical for a bar, it is inconsistent with health and safety within a residential community, particularly with the rise in gun activity observed in the vicinity of the premises.

1:00am is simply too late for a residential community. The majority of other eating and bar establishments on Grand Ave have earlier closing times and/or have NOT experienced the correlation of problems that this location has. An earlier closing sends the drinkers either home or to a commercial strip where this may be appropriate.
