Hello Greg,

Thank you for your patience as the data was pulled relative to alcohol sales/service on the St Paul campus of the University of St. Thomas.

I used the timeframe of 04/01/22 – 03/31/23 as a one-year span of time for this data set.

During that time, there were a total of one hundred twenty three (123) events on campus with alcohol service. Total alcohol sales for those (123) events was \$59,500, meaning an average of \$484.00 in alcohol sales/service per event.

Those events include weddings, banquets, receptions, hospitality suites, board of trustee events, and our home football pre-game bar service. Of these (123) events, there was the potential for our students or underage minors to be present at (5) weddings on campus, or at the (6) football pre-game bar services held on the plaza.
