Dear Pheng,

Thank you for contacting the City of Saint Paul about your Quarter 4 (October - December) 2023 garbage bill with Aspen Waste Systems. The charge of \$20.66 is not for Q4, however, but for Q3 (July - September). You may have paid your bill late, after September 30th, and those are the three late charges (one per month), which were probably added after you paid your bill.

As a result, Aspen Waste Systems sent your Quarter 3 (July - September) late fees to the City which the City paid on your behalf (that is why your payment history with Aspen Waste Systems shows a zero balance). Therefore, you currently owe the City \$20.66.

If you made the payment of \$20.66 to Aspen Waste Systems, you will be issued a credit in that same amount on your next bill. You may call your hauler to determine if a credit will be issued. You can find your hauler's contact information on the bill or by searching at <u>stpaul.gov/collectionmap</u>

If you paid the hauler your Q3 bill within the service period (by September 30th) and believe the late fees were applied in error, please provide verification of payment and we can research removing the assessment. If you would like to contest the assessment for any reason, you can request a legislative hearing. To do that you, you can reply to this email stating you'd like to appeal.

If you'd like to pay the assessment, listed on your letter from the City, there is a website (<u>stpaul.gov/assessments</u>) where you may pay online. If you prefer to send a check, there is also an address listed where you may send your payment:

Penniie,

I got in touch with Aspen about your overdue garbage bill assessment for Quarter 3 (Jul-Sep) of 2023. They confirmed that it was a mistake, so I will recommend that the assessment be removed.

The pending assessment for Jul-Sep 2023 will go to a legislative hearing on January 11, 2024. At the hearing, I will recommend a removal of the full amount and expect that it will be approved. If the hearing officer approves the removal, she will then make the same recommendation to City Council to have it removed.

You are welcome to attend the hearing in-person or by phone, but you do not need to. If you would like to attend, please let me know.

In the meantime, there is no need to pay the assessment. Let me know if you have any questions.
