I am not sure who your HVAC contractor is referring to as "the city". I have spoken with both the warm air and mechanical inspectors, neither has had communications with them. Which is good, at this point this will be coordinated through me until we get through our initial team inspection.

I will send out a team inspection scheduling invite for Thursday 5/18 at 11:00. I am hopeful this will work for everybody.

You mentioned that your intention is to use this as a primary residence, if that is true great. However, Herb, the man you had meet me onsite at my previous progress inspection, told me that this was going to be a Greek theme air bnb and that was the reason for the extensive tile in the home. In addition to that, I have never come across a home being used as a single family dwelling that has 3 dryers going into it. The electronic combination locks on each bedroom that allow access into the room by combination also lend themselves to air bnb. These things point to the intended use as air bnb. I will be monitoring the use of this building when it is complete to verify the use.

I am coordinating this to shed light on what has become a bit of a messy situation and to help you move forward and land this plane. It will be helpful for you to have as many of your contractors there as possible.

## Hello Clint,

I just wanted to let you know that I received your email and the inspection status report. I will share this report with the contractors.

Actually, after talking with you on April 23, 2023, I did reach out to my HVAC Contractor and I also reached out to my general contractor. My general contractor is flexible to meet. My HVAC contractor informed me that the City had already contacted him to coordinate a meeting which surprised me. Given this direct communication by the City with my HVAC contractor, so as not to create a scheduling conflict, I reasonably took a step back to allow the City to continue it efforts to coordinate a meeting with the contractors and with the five inspectors.

As you will recall from the last hearing, my office held a grand jury indictment from 2nd-degree murder, which has now become a first-degree murder trial that we will be prosecuting. It should be noted, I also work/reside approximately three hours of driving time away during the rush hour commute. Accordingly, for the sake of efficiency, whenever possible, I prefer to provide any information you may need remotely as I have a full-time job that expects me to be in court.

Lastly, I would like to clarify my intentions with the 733 Home. I intend to reside and owner-occupy the 733 Fairview Ave. North home. That is, to homestead the home and to make it my primary residence. Such has been my intention from the very beginning. I enjoy the neighborhood, I attended law school nearby, and my friends and

church are also very close. As you have seen, I have put a lot of capital into the home and my family is eager to reside there. They would not be pleased if plans changed and I told them the home will be converted into a bed-in-breakfast. I am not sure how this rumor came about, but that is not my intention. I wanted to be clear.

I do recall speaking to Nathan Bruhn by phone, whom I have included in this email. Nathan asked me why I had deadbolt locks installed on the doors upstairs in the 733 home. I informed Nathan that I purchased these locks years ago for my former residence in Minnesota, which was periodically rented each semester to the blended-learning law school students who were required to be here for 9 weeks. I explained that I rented my residence kind of like an Airbnb, to law school students while I was living and working in North Dakota. I also informed Nathan that the reason I installed these locks on the 733 rooms and pantry was so that I can secure my tools and supplies, and prevent valuable items from getting stolen from subcontractors, workers, etc. while I resided far away.

In sum, it is my intention to homestead the 733 home and live in it.

I have attached an inspections status report that goes back to when this project started, describing each permit, inspections done (or not done) and the status of the permit. This way we have transparency going forward on what was and was not inspected to this point. Please share this with your contractors and have a copy on hand when we have our inspection.
